II. Old Business

A. Approval of Minutes from Sept 12, 2022, Motion Max Andersen, second Todd Mockler

B. Burbank Schoolhouse Maintenance Cost Share: Rebecca shared that at a recent fundraiser approximately \$10,000 was raised and another fundraiser is forthcoming. Bids were requested to address the ceiling repair and bat/guano problem. One bid was received by Central Plains Bat Removal to remove bats, clean up all bat guano and add 10 in of insulation for a cost of \$8346.00. Linda Hawley shared that AMS Building Systems submitted a bid for Ceiling Repair for \$7055.22 with the possibility of reduction of costs depending of use of a lift and other circumstances. Linda stated she applied for a \$7000 grant with the National Historical society which won't be available until January of 2023. Motion by Todd Mockler second by Max Andersen to accept the Central Plains Bat Removal Bid at a 50/50 cost share with the Burbank Community Parks and Cemetery Association and to wait on the ceiling repair bid until the new year. It was mutually agreed that schoolhouse utilities and other costs would be shared 50/50 per the previous legal ruling.

III. New Business

Guests Kase Allison and Ann Schoellerman were present representing the interests of fellow residents. They questioned what procedure needs to occur to asphalt Missouri St and Saginaw. They suggested perhaps just adding the cost to the resident's taxes. It is estimated approximately 50 houses are involved. Max stated he recently met with MTA from Denver, Sioux Falls, and Minneapolis and nothing regarding blacktop was discussed in the money coming to the county. It was also discussed how various sub-communities both local and around the state have paid for the black-top themselves. It was determined that the residents would create a Road Association, investigate how other places have proceeded and start the process of asphaltting it themselves. The township would continue to maintain the roads if black-topped.

A. Warrant Listing: Tanna Miiller submitted October Expenditures in the amount of \$25,422.50 Motion by Todd second by Max to approve and pay the bills.
