

AGREEMENT: RELATING TO WAIVER OF MANDATORY ACCIDENT INSURANCE FOR STUDENTS PARTICIPATING IN SCHOOL ATHLETICS

THIS AGREEMENT, Made by and between School District No. 15, Washington County, Forest Grove, Oregon hereinafter referred to as SCHOOL, and (Parent's name) _____

Parent or guardian of (Athlete's name) _____, referred to hereinafter respectively as PARENT and STUDENT, Witnesseth: STUDENT is enrolled with SCHOOL and desires to participate in (sports/activity)

2026 Viking Boys Basketball Camp.

For the school year 2026-2027 and school shall permit participation in said sports activity only to those students who are named insured's upon policies insuring against loss and injury occasioned by accidents occurring as a result of participation in said sports activity, and does provide to all students within SCHOOL'S district a group plan of accident insurance and has offered said group plan to STUDENT and PARENT, and has requested payment of the premium charged therefore, and STUDENT and PARENT have requested payment of the premium charged therefore, and STUDENT and PARENT have requested a waiver of payment for the reason that adequate insurance is carried upon STUDENT by policies owned by the PARENT.

NOW THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

1. *PARENT covenants and agrees with SCHOOL that a policy or policies of accident insurance, naming STUDENT as a named insured or beneficiary thereof, is now in full force and effect and is issued by (Insurance Co.) _____ and according to the terms thereof, shall be in full force and effect for the school year 2026-2027.*
2. *PARENT further covenants that he has by independent investigation and inquiry with said company obtained assurance that the policy terms of said policy or policies do not exclude loss and injury due to participation in school –sponsored activities and sports, including all incidental transportation, and that the availability of a group plan insuring certain students within said district will not invalidate, limit, or deny coverage under PARENT'S private policy of insurance.*
3. *PARENT further covenants that said insurance shall be maintained during said school years, and in the event of cancellation thereof for any cause PARENT shall cause notification thereof to be forthwith delivered to SCHOOL and PARENT shall immediately do one of the following:*
 - a. Obtain substitute insurance without interruption in coverage and shall execute with SCHOOL a new WAIVER AGREEMENT, or**
 - b. Apply for and pay necessary premium for STUDENT'S inclusion in the appropriate group Student insurance plan offered by SCHOOL, or**
 - c. Remove STUDENT from participating in sports activities.**
4. *In the event of loss or injury to STUDENT due his participation in said sports activity, PARENT covenants that all demands and claims for damage and cost occasioned by said loss or injury shall be made to PARENT'S private insurance carrier named above, and to the policy limits thereof, shall hold SCHOOL harmless from any and all claims and demands for medical, dental, hospital or other related expenses and from any claim whatsoever resulting from said loss or injury.*
5. *In consideration of the covenants and conditions aforesaid, SCHOOL shall permit STUDENT participation in said sports activity, and does hereby waive payment of premium and participation of STUDENT AND PARENT in the said group student insurance plan. IN WITNESS WHEREOF, SCHOOL has caused this agreement to be executed by it's district clerk, and PARENT has set his hand and seal THIS _____ DAY OF _____, 20____.*
