The Division of Conservation Services (DCS) is part of the Commonwealth's Executive Office of Energy and Environmental Affairs (EEA) led by Secretary Rebecca Tepper.

The Division advises the Secretary on funding for the land conservation work of the EEA agencies - the Department of Conservation & Recreation, the Department of Fish & Game, and the Department of Agricultural Resources - and provides grant funds to cities, towns, and land trusts to help them to purchase and develop land for conservation or recreation purposes. DCS also reviews/approves all perpetual Conservation Restrictions and municipal Open Space & Recreation Plans in Massachusetts, administers the State Conservation Land Tax Credit Program, and supports Conservation Districts.
