# **Bitrise Privacy Notice and Consent Form for Testers**

### 1. SCOPE

This Privacy Notice ('Notice') provides you with information regarding the processing of your personal data carried out by **Bitrise Limited** (registered seat: 3 Waterhouse Square, 138-142 Holborn, London, England, EC1N 2SW); email: letsconnect@bitrise.io) ('controller', 'we' or 'us').

This Notice only applies to the data processing in the context of you providing us with user experience and user interface ('UX&UI') testing of our website and application as a service, during pre-agreed testing sessions, and to any outputs of such service, including but not limited to documentation, materials, suggestions, comments, feedback or reports created by you (collectively referred to as 'the Services'), in connection with and to the extent necessary for the negotiation or performance of the Contractor Testing Services Agreement.
