To whom it may concern,

The arrest of the Madleen in international waters - and the detention of its 12 member crew - constitutes a grave violation of both domestic and international law. These individuals were delivering essential aid to a besieged population enduring genocide, starvation, and the deliberate weaponisation of aid.

Their only "crime" was carrying the basic necessities for human survival.

By failing to act, your government risks continued complicity in these violations. We demand:

1. Immediate intervention to secure the release of your unlawfully detained citizens.

2. Condemnation of this act of piracy by an occupying regime already ruled as a criminal state.
3. Divestment from all economic and military ties enabling this terror.

International courts have ruled: this is a genocide. Your legal and moral obligations are clear.

Prove us wrong.

Free your citizens. End the siege. Ceasefire now.
