**260623/05 Matters Arising:
Highways Update - Cllr M Campbell
Cllr M Campbell presented 4 options for progressing the
extension of the 30mph speed limit. It was noted that 2 letters
of support had been received and circulated to Members.**

**Members thanked Cllr M Campbell for the work that
he had undertaken but agreed that a decision could not be taken
until after the September meeting of the Parish.**

**Cllr A Sharp informed the meeting that he had been in discussion
with the Highways Department who are considering providing
signage at the Mill Lane bend.**

**In response to a question Cllr M Campbell confirmed that
Highways work would be carried out through the Highways
Department.**

260623/06 An updated CIL report was circulated by the Clerk.

260623/07 Neighbourhood Plan - Cllr J Dennis

Cllr J Dennis informed the meeting that the development of a Neighbourhood Plan involved a number of steps which would require a Working Party, and could take up to 3 years to complete.

When the Plan was finalised it would feed into the Development Plan and Local Plan for East Cambridgeshire, which are used to determine wider Planning issues. The level of CIL monies for the Parish would also be increased from 15% to 25%.

Financial support could be available for professional advice.

It was agreed that Cllr J Dennis would contact J. Wilson at Cheveley Parish Council to discuss their progress, and present a further report.

260623/08 Future Consultation/Communication with Residents:

It was agreed to hold a Village Meeting on 25th September starting 1.00 hour ?????? before the Parish Meeting. This would give Councillors an opportunity to 'Meet and Greet' Residents. A number of issues would be discussed including priorities for future spending of CIL, the development of a Neighbourhood Plan, footpaths, plus any other items Residents wanted to discuss.
