*Note 1: this addiction is different from the Technology Addiction topic, which has more to do with behavior using technology & devices vs. this one which is geared toward substances and pleasure circuits in the brain.

**Note 2: as with other topics, this one often crosses paths with the mental health and the homelessness topics. However, make sure if you're choosing this one, that the primary focus is on the addictive behavior rather than the potential effects of that behavior (i.e. homelessness or mental health issues).
