Artwork process and deadline:

I will begin working on the commission after all commission info is settled.

1. **Sketch.** Composition/pose/emotions corrections are available at this step.
2. **Full Payment.** Deadline two weeks from payment.
3. **Line-art.**
4. **Base colors.** If you have a REFERENCE, not a text description, color scheme corrections are available at this step. I won't be "trying" colors.
5. **Finished art.**

- Commissioners have my permission to post their commission artwork on any website for personal use and may credit my nickname.
- Commissioned artwork can be used strictly for the client's personal use. Do not use it for promotional or commercial purposes, unless there was an agreement to it and you've paid commercial use fee (which is negotiable).
- I publish all my work in my portfolios. You can pay extra (20%) for the confidentiality of the drawing.
- Commissioners do not have permission to edit any art you have received from me, or have another artist alter any of my work (See Copyright Policy). Only exception is cropping for the avatar/icon.
 - Don't use your commission for NFT purposes.
 - Don't use your commission in any AI generators.
- All clients requesting a commission must be age 18 or older.
