<u>Terms & Conditions – Unacademy Aim Scholarship Test</u> (Free Scholarship Test)

- 1. The Unacademy Aim Scholarship Test ("Unacademy Aim" and/or "Test") is a free scholarship Test organized by Sorting Hat Technologies Private Limited ("Unacademy"). The Test shall be valid only within the territory of India.
- 2. The test shall be governed by the terms and conditions defined herein, as well as the Terms and Conditions of the platform, the online Privacy Policies, and Community Guidelines available on Unacademy's platform (www.unacademy.com & Unacademy Apps) ("Platform")
- 3. Those participating in Unacademy Aim shall be hereinafter referred to as the "Participant/s".
- 4. The Participants shall be eligible to win prizes and scholarships ("**Prizes**") as provided on the Unacademy website, and such Prizes shall be subject to the Terms and Conditions are given herein. The details of the Prizes shall be as provided on the Unacademy's Platform or as communicated over email or any other mode of communication.
- 5. Eligibility and number of Prizes for the top rankers of each respective school shall be subject to the number of participants who have enrolled and attempted the Test(s), specification of such Prizes will be as communicated to the respective School,
- 6. In order to become a Participant in Unacademy Aim, the Participants must conform to the following eligibility criteria in addition to the Test specific eligibility criteria listed in these terms and conditions:
 - (i) an Individual;
 - (ii) an Indian citizen;
 - (iii) residing in India;
 - (iv) legally eligible to enter into a contract;
 - (v) must be a registered user of the Unacademy platform.
- 7. Information that is available on the official Unacademy Aim page on the Platform or communicated on Unacademy's official social media handles shall be the only authentic and valid information with respect to the Test. Unacademy shall not be responsible for any incorrect/misleading information relating to Unacademy Aim, presented/ displayed on any other source other than the Unacademy Aim page on Unacademy's Platform & shall not be liable for any loss suffered by any Participants based on the representation, terms and conditions, the information presented/displayed on any other source other than the Unacademy Aim page.
- 8. To participate in Unacademy Aim, the Participants are required to follow the following steps:
 - (i) Signup or log into the Unacademy's Platform to access the Unacademy Aim website.
 - (ii) Attempt any of the active tests according to the eligibility criteria;
 - (ii) Participants ought to attempt the Test to remain eligible for all the Prizes.
- 9. A Participant who has received a Prize for one Test shall not be eligible for a Prize in the other Tests, irrespective of their Unacademy Aim ranking.
- 10. After the results are announced, Unacademy will conduct a thorough evaluation to determine if the Participants have conducted themselves in accordance with the Unacademy Aim Terms and Conditions.
- 11. If at any point in time it is brought to the attention or knowledge of Unacademy that the Participants have engaged in any unethical practices including but not limited to having prior access to the questions in the Test series, usage of any circumventing technology to manipulate the product

- algorithm or any act which will give a Participant an unfair advantage over other Participants, Unacademy may at its sole discretion cancel any Prize or reward due to the Participant and may restrict the Participant from participating in future tests conducted by Unacademy.
- 12. All Prizes and rewards are subject to the Participants adhering to the Unacademy Aim Terms and Conditions and the Terms and Conditions of the Unacademy Platform.
- 13. The product algorithm evaluates the Participants based on the speed and accuracy of the answers to be displayed on the leaderboard.
- 14. Unacademy has endeavored to make all reasonably practicable arrangements to minimize communication system difficulties or any other technical issues but can make no guarantee thereof and shall not be liable for any failures in the same. Unacademy shall not be responsible and/or liable in any manner whatsoever in case the Participant is unable to participate due to any technical issues or due to the issues with their internet provider, hardware, facility provider, etc.
- 15. Any Participant found participating in the Test through multiple accounts shall be disqualified immediately and shall not be entitled to any Prizes. The Participant shall be barred from participating in any future contests, tests or Unacademy Aim itself at the sole discretion of Unacademy.
- 16. Unacademy Aim is open to participation by individuals only. Corporate entities, agencies and any non-human legal entities are barred from participating in Unacademy Aim. Employees, consultants, interns and educators Unacademy employees and educators are not allowed to participate in Unacademy Aim.
- 17. There is no entry fee or participation fee payable by the Participant/s and Unacademy does not accept any form of payment to be able to participate in the Test.

Any Participant taking part in Unacademy Aim and is declared as a top ranker of the Test Unacademy Aim by Unacademy and is unable to fulfill any one or more eligibility requirements, as specified in the abovementioned clauses of these Terms and Conditions, on the last date of the Test, shall be disqualified from receiving any Unacademy Prizes under this Test. Any communication, clarification, query, dispute in this regard by the top ranker, or any of the legal heirs/guardians of the top ranker in any manner shall not be entertained by Unacademy.
- 19. Collection of Prize shall be subject to:
 - (i) Upon successful completion of the process i.e., responds within 7 days of communication from Unacademy team
 - (ii) Verification of ID
 - (ii) Provision of correct details (address, phone number)
 - (iii) Prizes shall be dispatched or communicated in 2-3 weeks and shall be delivered within 90 days after successful completion of verification.
 - (iv) It is agreed and understood that in the event, wherein the Prizes towards the top rankers of each school, has been provided by Unacademy to the school through which the Participant has enrolled, then the school shall be responsible for providing the said Prizes to each respective top ranker.

Unacademy shall not be liable for any loss, claim, damage, expenses whether expressed, implied, real, or consequential incurred by the Participant due to participation, non-participation or otherwise in the Unacademy Aim. - 25. The Top Rankers shall submit the necessary documentation/proof of identity and other relevant documentation as requested by Unacademy, within 7 days of receiving intimation from Unacademy.
- 26. The Prizes are non-endorsable, not transferable, and non-substitutable. The Prizes are offered on a 'NO EXCHANGE-NO REFUND' basis. Unacademy will not entertain any requests for exchange in lieu of the Prize(s).
- 27. Each Top Ranker shall provide the following documentation to enable Unacademy to dispatch the Prize to the Top Ranker:

- 28. Unacademy reserves the right to modify, add or delete any of the terms and conditions at any point of time at its sole discretion without serving any prior intimation.
- 29. Any disputes with respect to Unacademy Aim shall subject to be governed by and construed in accordance with the laws of India, without reference to principles of conflict of laws and the courts in Bangalore shall have the exclusive jurisdiction to determine any disputes arising out of, under, or in relation to, this Unacademy Aim.
- 30. The top rankers by attempting the Tests and agreeing to the Terms and Conditions, provide their consent to Unacademy and assign the right to use their name, image, or visual representation, testimonials, comment, or statement, in any media for promotional, marketing, and advertising purposes or any other objective by Unacademy, as deemed appropriate by Unacademy.
- 31. The Participant shall indemnify and hold harmless Unacademy, its officers, employees, agents, licensees, etc against any and all damages, claims, losses, demands, actions, causes of action, suits, litigation, costs and expenses (including but not limited to, the publication of response(s) submitted by the Participant as a part of, or in association with the Unacademy Aim without limitation, reasonable attorneys' and consultants' fees).
- 32. Unacademy shall not be liable for any failure to comply with its obligations caused by weather conditions, fire, flood, strike, hurricane, industrial dispute, war, hostilities, terrorist attack, political unrest, riots, civil commotion, inevitable accidents, pandemic and/or epidemic, acts of God or any other circumstances amounting to Force Majeure.

- 33. Unacademy shall not be responsible for any loss or damage. If Unacademy is required to discontinue or cancel the Unacademy Aim in compliance with any law, ruling, order, regulation, requirement, or instruction of any Central/State Government or for any other unavoidable reason beyond its control. The Participants shall be informed of such discontinuance/cancellation as early as possible.
- 34. The aggregate liability of Unacademy in case of any damage, loss, cost, claim, liability, or expense (including legal costs and expenses) caused to or incurred by any act, omission, or representation in respect of the Prize of Unacademy Aim to any Top Rankers, shall not exceed the value of Prize INR 50. Further, Unacademy shall not be liable to share the invoice of the Prize unit with the Top Rankers at any given point of time whatsoever.

- 37. Participants shall be eligible to avail Prizes for a maximum of 1 Main Unacademy Aim Test, subject to meeting the eligibility criteria and post the Test verification of the Test. Unacademy has the sole discretion with respect to the distribution of the Prizes and shall decide the eligibility of a Participant to receive the Prize if it has a reason to believe the Participant has engaged in unfair practices or has *mala fide* intentions.
- 38. Ranking Criteria: Participants securing the highest marks in the least possible Test time shall be used as the criteria to determine the ranks. In the event where two or more Participants secure the same mark, the time taken to complete the Test shall be used as a tiebreaker and the Participants with lesser time taken to complete the Test shall be ranked higher.
- 39. Plus/Iconic subscribers can also participate in all the tests (Main Unacademy Aim Test and Practice Tests), but they will remain eligible only for the rewards, and not the Unacademy Scholarships.
- 40. Participants hereby give their consent to Unacademy to market & promote the likeness and secured ranks of the Participants, which have been attained in the official IIT JEE (Mains and Prelims) and NEET UG examinations conducted.
