

TOWN OF FOND DU LAC 2025 TAX COLLECTION NOTICE

Tax collection for 2025 taxes will be at Bristol Morgan Bank, 171 S. Pioneer Rd, FDL, on Monday, December 29th & Tuesday, December 30th, 2025 from 9:00am-4:00pm. Taxes will also be collected for 2025 at Bristol Morgan Bank on Wednesday January 28, 2026, from 9:00 am-4:00pm.* **In person tax collection subject to cancellation without notice.**

FULL PAYMENTS ON REAL ESTATE, PERSONAL PROPERTY, SPECIAL ASSESSMENTS, OR 1st INSTALLMENTS ON REAL ESTATE ARE DUE BY JANUARY 31, 2026 to the TOWN TREASURER, address listed below if you are sending your tax payment by mail. If would like a payment receipt please enclose a self-addressed stamped envelope. (Payment is considered timely if it is mailed in a properly addressed envelope with a U.S. Postal Service postmark before midnight of due date – ***it is your responsibility to check with your local post office to verify when postmarking is completed as procedures have changed.***) ***Refunds on overpayments will be held until the check clears the bank & mailed to homeowner.***
2nd INSTALLMENT PAYMENTS MADE AFTER JANUARY 31, 2026 SHOULD BE MADE PAYABLE AND SENT TO: FOND DU LAC COUNTY TREASURER, 160 S. MACY ST., PO BOX 1515, FOND DU LAC, WI 54936-1515.

The enclosed tax slip shows your assessed valuation, present tax rate, and the estimated fair market value. The State has provided for one credit known as the State School Credit which is the same regardless of which School District. Your tax rate is based on the amounts levied to the Township by the State of Wisconsin, County of Fond du Lac, Moraine Park Technical College, the school district you reside in and the Town of Fond du Lac. The Town tax of \$2.1898850 per \$1,000.00 of valuation represents \$708,221.00 placed in the Town's General Fund for general operating expenses, \$183,878.00 placed in the Water Utility Fund, \$45,000.00 for the new fire truck and \$300,000.00 for debt retirement.

When paying your STATE and FEDERAL INCOME TAXES, or applying for any VEHICLE LICENSE, please give your address as the TOWN OF FOND DU LAC.

DOG LICENSE INFORMATION: All dogs in the Town of Fond du Lac must be licensed. **Dog License fees are due EVERY YEAR when paying your taxes. No license will be issued without proof of rabies vaccination.**
