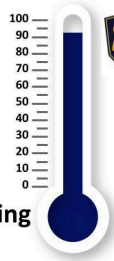

Do you know about Qualified Charitable Distributions?

- Do you know someone **who is 70 1/2 or older? Maybe it is you?**
- A donor may transfer up to \$100,000 a year even if their **Required Minimum Distribution (RMD)** is less than this amount. *(If filing taxes jointly, a spouse can also transfer up to \$100,000, making the total \$200,000.)* The amount in excess of the RMD is not treated any differently, for tax purposes (it does not count as income and you do not take an itemized deduction for the amounts)
