# Summer 2025 OERI Public Speaking Summary Updated 8-26-25

### Overview

During the summer of 2025, a group of communication studies faculty was convened for the purpose of identifying available open educational resources (OER) that could be used to support content and objective elements identified as being additions to what was normally covered in public speaking courses prior to recent statewide curriculum changes. The determination of what was new was made by comparing the existing expectations associated with the Course Identification Numbering System (C-ID) descriptor for <u>COMM 110</u> with the <u>Common Course Numbering</u> <u>C1000 template</u> and the expectations for the course as meeting CalGETC Area 1C (Oral Communication; see page 23 of <u>CalGETC Standards Version 1.2</u>).

The additional elements are summarized in the table below.

Additional Content and Objectives/Outcomes Potentially Needed to Ensure Public Speaking Text Alignment with the Common Course Numbering C1000 Template and the CalGETC Standards Version 1.2 for CalGETC Area 1C

#### Content

Foundational rhetorical theories, including the canons of rhetoric and Aristotelian proofs, as well as relevant principles of human communication.

Critical analysis of historical and contemporary public discourse.

Rhetorical sensitivity to diverse audiences.

#### **Objectives/Outcomes**

Apply rhetorical theories to create and analyze public speeches in a variety of contexts including historical and/or contemporary.

Demonstrate rhetorical sensitivity to diversity, equity, inclusion, accessibility, and belonging and adhere to ethical communication practices which include truthfulness, accuracy, honesty, and reason.

Various analyses were conducted to assess which of the identified elements could be found in existing OER. In addition, the members of the convened group did their own analyses. Through the discussions of the group, it was determined that most of the elements were covered to some extent in most texts and many were likely taught by most faculty teaching public speaking - but it was recognized that some faculty might find it useful to have a resource that assisted them in finding related content, should they wish to supplement the resources they were presently using.

As a consequence, the resources provided below were gathered to assist faculty seeking additional content. These resources have not been subjected to review and may not be comprehensive. This document should be viewed as a work in progress. Please share any feedback you may have - as well as additional resources - with the OERI.

Recently, <u>Essentials of Exemplary Public Speaking</u> was completed. This textbook was created specifically for today's California Community College public speaking students and includes carefully curated content from a variety of public speaking textbooks. This textbook was specifically designed to support a speech course aligned to the Common Course Numbering (CCN) template for COMM C1000. In addition, subject matter has been revised and edited to include updated research, examples geared toward community college students, and citations. Students who read this textbook will learn and apply foundational rhetorical theories and techniques of public speaking in a multicultural democratic society. Students will discover, and critically analyze ideas in public discourse through research, reasoning, organization, composition, and delivery.

The OERI is still planning on creating a supplemental resource to provide potentially missing content and to establish a collection of speeches that may be used in your teaching. A <u>Canvas shell</u> of available OER for teaching public speaking is available in <u>Canvas Commons</u>.
