

Second Chance Cashback Promotion Terms and Conditions

Terms and Conditions

1. General Conditions

1.1 These terms and conditions (the “Terms and Conditions”) govern the participation of users in the “Second Chance Cashback” Promotion (the “Promotion”), organized by iCash.One (the “Promoter”).

1.2 All capitalized terms not defined herein shall have the meaning ascribed to them in the iCash.One General Terms and Conditions available at: <https://www.app-terms-conditions.icash.one/>.

1.3 By participating in this Promotion, users agree to be bound by these Terms and Conditions and the iCash.One General Terms.

1.4 In the event of any inconsistency between these Terms and the iCash.One General Terms, these Terms shall prevail with respect to matters relating specifically to the Promotion.

2. Scope and Description of the Promotion

2.1 This Promotion is operated by iCash.One and offers Eligible Users (as defined in Section 4) a 50% cashback on their next qualifying deposit made through iCash.One to any merchant adhered to iCash.One (the “Cashback”), subject to a maximum reward of USD 10,60 (or the equivalent in local currency as determined by iCash.One’s system conversion rates).

2.2 The Cashback will be calculated automatically by iCash.One’s system based on the amount of the qualifying deposit and credited to the user’s iCash.One Digital Application Account, subject to the conditions set forth herein.

3. Promotion Period

3.1 The Promotion shall be effective from June 5th, 2026, until June 18th, 2026, both dates inclusive (the “Promotion Period”).

3.2 Only qualifying deposits made during the Promotion Period shall be eligible for the Cashback. Deposits made before or after this period shall not qualify.

4. Eligible User

4.1 The Promotion is applicable to users that have an account in iCash.One Digital Application.

4.2 You must be over 18 years old.

4.3 You must hold a valid iCash.One account that is active, duly verified, and not subject to suspension or restriction.

4.4 You must have received direct communication from iCash.One regarding this Promotion.

4.5 iCash.One reserves the right, at its sole discretion, to determine whether a user meets the eligibility criteria based on internal records and transaction history.

5. Cashback Reward

5.1 Eligible Users will receive 50% Cashback on their next qualifying deposits made through iCash.One during the Promotion Period.

5.2 The maximum Cashback amount a user may receive under this Promotion is USD 10,60 (or the equivalent in local currency as determined by iCash.One's system conversion rates).

5.3 Once the Cashback is credited for the qualifying deposits, the Promotion shall be considered exhausted for that user, and no additional Cashback will be granted under this Promotion.

6. Payment of Cashback

6.1 The Cashback will be credited to the user's iCash.One account after the qualifying deposit is successfully completed, subject to no technical or operational delays.

6.2 iCash.One shall not be responsible for delays or failures in crediting Cashback caused by technical issues, third-party systems, or circumstances beyond its reasonable control.

7. Monthly Promotional Reward Cap

7.1 Notwithstanding any individual reward caps set forth in the applicable promotional terms and conditions, the total aggregate amount of rewards, cashbacks, and benefits credited to a user's iCash.One Digital Application Account balance through any and all active promotional campaigns shall not exceed USD 50 (fifty United States Dollars), or applicable local currency, per calendar month (the "Monthly Cap"). This limit applies globally across all concurrent promotions, and the exception of rewards derived from iCash.One's lottery-based campaigns.

7.2 The Monthly Cap shall reset on the first (1st) day of each calendar month. In the event a user reaches the Monthly Cap prior to the end of the calendar month, any additional rewards or cashbacks that would otherwise be credited under any active promotion shall not be accrued or credited.

7.3 iCash.One reserves the right to modify the Monthly Cap amount at any time.

7.4 iCash.One further reserves the right, at its sole discretion, to restrict, suspend, or exclude any specific user from participating in any or all active promotional campaigns, at any time and without prior notice, based on internal eligibility criteria, risk assessment, or compliance considerations.

8. iCash.One's Rights

8.1 iCash.One reserves the right, at its sole discretion, to modify, suspend, or terminate the Promotion, in whole or in part, at any time without prior notice.

8.2 iCash.One reserves the right to disqualify any user from the Promotion if fraud, abuse, manipulation, or misuse of the Promotion is suspected.

8.3 iCash.One's determination regarding eligibility, Cashback calculation, and account crediting shall be final and binding.

8.4 iCash.One reserves the right to withhold, revoke, or recover any Cashback credited in error or in violation of these Terms.

8.5 Any notice or update related to the Promotion may be communicated via in-app notification, email, or publication on the iCash.One website and shall be

deemed effective upon such communication.

9. Limitation of Liability

9.1 To the maximum extent permitted by law, iCash.One, its affiliates, directors, officers, employees, and agents shall not be liable for any loss, damage, cost, or expense arising out of or in connection with participation in this Promotion, including but not limited to:

- a. Technical failures, system errors, or interruptions;
- b. Loss of Cashback due to unauthorized access or third-party actions;
- c. Acts or omissions of merchants or third-party partners;
- d. Reliance on promotional materials or communications related to the Promotion.

9.2 This Promotion is provided “as is” without warranties of any kind, whether express or implied.

9.3 The Cashback amount reflected in the user’s account shall be final and conclusive.

10. Force Majeure

iCash.One shall not be liable for any failure or delay in the performance of its obligations under these Terms due to events beyond its reasonable control, including but not limited to acts of God, system failures, or regulatory actions.

12. Dispute Resolution

Any dispute arising in connection with this Promotion shall be resolved at the sole discretion of iCash.One, whose decision shall be final and binding.
