- Any changes to this after submission will need to be submitted via a [Substitution Form](#).

### Judge's Script:

Please mail a copy of your script to EACH judge at the address above by **March 28, 2025**. It takes time for an adjudicator to review your script. Make sure your school's name is on the inside of the script.

- Do not use signature confirmation for delivery.
- Do NOT send a Xerox copy.
- Make sure the scenes/dialogue/stage directions you are not using are “x-ed” out in pencil or black pen and can still be read and that the remaining dialogue (and/or stage directions) is highlighted in yellow. Some judges prefer reading the entire script and then reading your cutting, so make sure what you are not using is still legible (pg. 37).

#### Required Documentation for Official Rehearsal:

- Proof of **Royalty Payment** for Play (not required if within public domain)
- Publisher’s **Permission to cut** (not required if within public domain)  
*Please note this is different from the royalty payments. If planning on internal cuts, they MUST be approved by the publishers, regardless if your play was approved by UIL or your play is on the UIL Approved list.*
- **State UIL Approval Letters**
  - Play approval if not on the [approved list](#).
  - Permission for additional scenery or special properties or any written clarification from the State UIL office.
- [Community Standards & Copyright Compliance Form](#) signed by your principal.
- A clearly marked **Integrity Script** reflecting the performance text (this is in addition to the adjudicators script). It should mirror the judge’s scripts with the addition of any live music cues (pg. 37). **In order to be allowed to rehearse you must have the integrity script (pg. 37).**
- [Substitute Form](#) for any changes made that are different from your Online Entry.
- [Critique Attendance Waiver](#) – if any students will miss critiques.

### Rehearsal & Performance Schedules:

Each school should arrive/unload at least 30 minutes prior to rehearsal time. Each school will have 60 minutes of uninterrupted time to rehearse (pg. 78).

*All performance orders have been done by Blind Draw. Order for bi-district, area or regional meets shall be drawn by district or area numbers. Play order shall be determined alphabetically by the title of the play when two plays are from the same zone/district, bi-district or area (pg. 62). If you would like to request video documentation of the draw please reach out to the contest manager.*
