#### **Purpose of funds:**

Funds for race registrations

- The running club is a member of NIRCA which host races for students
- The club is for people who want to run but don't want to join Cross Country
- Has approval for Ann Mccaron
- Requesting up to 20 runners. Asking for funds for the gas and registration for the runners for four separate racers
- First race is on 9/14/24.
- NIRCA Cross Country Northeast Regional on 10
- Canal Diggers 5k: 461.70

#### **Discussion:**

- Point: Brown Bear is Brown Universities running club
- Con: Students should pay if they want to complete in the competition
- Question: Are they a club sport
  - Yes
- Pro: Makes sense for them to complete, and a low cost per person
- Con: They have 30 active members running, but are only sending 20
- Pro: Fits the purpose of the club
- Pro: If not everyone goes, we will not spend the money
- Con: Not comfortable with the selection process
- Pro: Selection process with priority seems fair. Only spending the money for people who want to go
- Pro: This can help grow their club
- Con: The same 20 people may be going to each race

**Outcome:** Passed in full.

**F.25.2 Running Club (\$2036.43)--PASSED**

**Purpose of funds:**

**Presentation: -**

**Questions:**

Q: How will the 20 runners be selected for the race?

A: Tracking attendance to runs and giving priority to those who attend club runs more often

Q: Why these events? Could you find any volunteer events with other schools?

A: There are not many of those events around. The ones that exist are either not great or very expensive.

Q: Who is hosting the Brown Bear invitational?

A: Not sure

Q: What is attendance to daily runs?

A: Typically 30 students attend the runs

### **F.25.3 Outing Club (\$2087)--PASSED IN AMENDED AMOUNT**

#### **Purpose of funds:**

White water rafting

#### **Presentation:**

- September 8th, White Water Rafting
- 30 students will attend

#### **Questions:**

- Have you explored any options for rafting?
  - One other company was more
- Why the increase?
  - More people, and rafting is more expensive now

#### **Discussion:**

- Tickets should be funded at 60%
- Motion: Ticket costs amended down to 60%
  - Discussion:
    - Pro: Fiscally responsible
    - Pro: Fits the bylaw
- Pro: Very desirable event on campus
- Pro: Expanded it due to high popularity last year

**Outcome:** Passed in amended amount.

#### **F.25.4 Outing Club (\$2871)--DENIED**

##### **Purpose of funds:**

Weekend on the Cape trip

##### **Presentation:**

- September 7th-8th Weekend on the Cape
- 13 members, 2 officers, 1 advisor
- Renting minivans for transportation
- Renting bikes for rail trail
- Request also covers gas, food, and tickets

##### **Questions:**

- Have you talked to SAO
  - Not yet
- How do you decide who goes on the trip
  - First come first serve
- How many people will be eligible
  - Had 175 people at GBM

##### **Discussion:**

- What is Food & Fuel?
- Do campsites count as tickets or lodging?
- Point: We only fund 60% of tickets and lodging
- Motion: Amend campsite down to 60%
  - Pro: Fits the bylaw
  - Approved
- Point: Food and Fuel is firewood
- Motion: Remove food and fuel
  - Failed
- Motion: Amend the surf lessons down to 60%
  - Pro Fits the bylaws
  - Approved
- Point: Current amended amount is half the student life fee per person
- Con: It is an exclusive opportunity, and is too expensive. It is not beneficial for the whole student body, it is only beneficial to the 13 members
- Con: Safety concerns. Not SAO approval
- Point: Potentially table it
- Point: If we deny they will have time to appeal

**Outcome:** Request denied.

### **F.25.5 Filipino Student Association (\$167.32)--DENIED**

#### **Purpose of funds:**

GBM Funds

#### **Presentation:**

- A term GBM has an expected attendance of 20-30 members
- Will serve as an intro to the club and exec. Also seeking candidates for the new exec.
- Offer free prizes for those who attend
- Requesting funds for candy, prize, and equipment for GBM
- Currently do not have a line item in the budget for these items
- The equipment can be used for future table sittings

#### **Questions:**

- Do you only have 4 GBMS a term and is this the only event?
  - This is not the only event, and yes only 4 GBMS
- Do you have an retreat events planned? Or in past?
  - No
- Have you talked to SAO about spinners? Have you talked to ATC about mics?
  - Not yet
- What is the purpose for the food?
  - Food is as prizes
- How many members typically show up to GBM?
  - Typically 30
- Is GBM open to all of campus?
  - Yes it is

#### **Discussion:**

- Con: Equipment can be found on campus
- Con: No food and no prizes
- Pro: Fits the purpose of the club
- Con: Does not follow bylaws
- Con: This goes over the amount of money for prizes allowed

**Outcome:** Request denied.

## **F.25.6 Powerlifting Club (\$12493)--PASSED IN AMENDED AMOUNT**

### **Purpose of funds:**

Paid practices

### **Presentation:**

- Powerlifting is a high upfront cost. The hope is to make it more accessible to students
- 3 students competed at the USAPL meet
- Currently practice at Evolve training 8 mins away
- Currently provide transportation to the Evolve
- Continue working with Alec, their current coach
- 13 total practices for the fall semester
- Transportation: \$6,825
- Gym memberships: \$3,168
- 50% of Coaching costs: \$2,500

### **Questions:**

- Do only 20 members get coached?
  - Yes it is only those who want to pay
- Have you looked at other transportation options?
  - McCarthy and Sons is what was recommended
- Average attendance to practices?
  - 15 people
- Why requesting for 20 people?
  - Some people will go on their own time
- What was the number of memberships from last year?
  - 25

### **Discussion:**

- Motion: 66 to 60
  - Pro: Fits the bylaws
  - Approved
- Con: Not comfortable with the personal membership aspect
- Pro: Allows the people to compete
- Point: Could we require 50% attendance for gym membership
  - Point: We do not have the power to do that
- Pro: Only an incremental increase for a popular club

**Outcome:** Passed in amended amount.

## **F.25.7 Sigma Alpha Epsilon (\$2500)--PASSED WITH STIPULATION**

### **Purpose of funds:**

Event funding

### **Presentation:**

- SAE kickoff sept 4th-5th noon to four
- First day: Bubble soccer
- Second day: BBQ, lawn games
- All food through chartwells
- Will market through social media, outreach to other clubs
- Event used to occur before COVID

### **Questions:**

- Tickets?
  - No
- Did you check with other clubs for collaboration?
  - Yes
- Have you talked to the events office about BBQ?
  - Yes?

### **Discussion:**

- Are we paying for a recruitment event?
- Con: There is another event during the weekend
- Pro: In favor except has the events office and chartwells approved this?
- Con: During the school day, and they have not gotten approval
- Pro: The event is saying go greek
- Point: The event happening the following weekend is a fundraising event
- Pro: It benefits all of campus, is free and open to anyone
- Con: Bubble soccer is not open to everyone
- Point: They will usually swap people out
- Motion: Stipulation to talk to events office, SAO, Chartwells
  - Approved

**Outcome:** Passed with stipulation.

### **E.25.8 Women's Club Soccer (\$3000)--PASSED**

#### **Purpose of funds:**

Funding for games

#### **Presentation:**

- 31 ug student participants
- Just separated from Men's club soccer, need an increase from their new budget
- Funding covers transportation and EMS, and refs for games

#### **Questions:**

- Is this a similar budget that you received with men's club soccer?
  - Yes

#### **Discussion:**

- Point: Were given a budget, treasurer did not request enough
- Pro: FPOC
- Pro: Need more money to do the things we already approved
- Pro: Cool that they are using their budget first

**Outcome:** Passed in full.

### **F.25.9 HinduYUVA (\$2403)--DENIED**

#### **Purpose of funds:**

Hindu Festival to bring people together

#### **Presentation:**

- Fund for Hindu festival to bring students together
- Expect 600 people at the festival over two days
- September 7th and 8th
- This is a line item in the budget but they are requesting more to have more food for the higher expected attendance
- Requesting 2403

#### **Questions:**

- Talk more about the food?
  - External vendor who has been approved
- How many expected attendees?
  - Around 600
- Tickets?
  - No
- Why did you go over budget last year?
  - Ran out of food quick, and had a high attendance
- Have you talked to GSGA about receiving funds for grad students?
  - They do not have their budget yet, SGA is last resort

#### **Discussion:**

- Point: They are budgeted for the undergraduate portion of this event
- Con: We would fund it, however we can not fund graduate students
- Con: Undergraduates pay for the student life fee
- Motion: Stipulate they create a system to check for grad students
  - Failed
- Point: Recommend they can do that by selling tickets
- Point: How much communication do we have with GSGA?
- Con: Worried about amount they are requesting

**Outcome:** Request denied.
