ARTICLE I — PURPOSE

Pursuant to the sovereign authority vested in the Monarch under Article I, Section 2 of the Constitution of the Kingdom of Solmeria, and in furtherance of Article XIV of the Constitution of the Kingdom of Solmeria (Founding and Ratification), this Royal Decree is issued to formally record the ratification of the Constitution of the Kingdom of Solmeria, and to confirm the retirement of the prior Constitution as a governing instrument of the Kingdom.

ARTICLE II — RATIFICATION OF THE SECOND CONSTITUTION

The Constitution of the Kingdom of Solmeria, is hereby ratified and takes effect immediately upon the issuance of this Decree. It supersedes and replaces the prior Constitution, in its entirety, consistent with Article XIII of the Constitution of the Kingdom of Solmeria.

The prior Constitution is retired as a governing instrument of the Kingdom of Solmeria. It holds no legal force and may not be cited as authority for any act, decree, or decision of the Kingdom. It is preserved solely as a historical document.

All governing authority of the Kingdom of Solmeria now flows from the Constitution of the Kingdom of Solmeria, and from Royal Decrees and enacted laws issued in accordance therewith.

ARTICLE III — CONTINUITY OF DECREES, APPOINTMENTS, AND MEMBERSHIP

Consistent with Article XIII of the Constitution of the Kingdom of Solmeria, the following continuity provisions apply immediately upon ratification:

All Royal Decrees lawfully issued under prior governing instruments remain in full force unless they contradict the provisions of the Constitution of the Kingdom of Solmeria, in which case they are void to the extent of the contradiction.

All members of Parliament at the time of ratification retain their seats. All ministerial appointments in effect at the time of ratification remain valid. All admitted States and Territories retain their status under the Constitution of the Kingdom of Solmeria and under Article XII thereof.

ARTICLE IV — REFERENCE CORRECTION

Any reference in a prior Royal Decree to the "Constitution of the Kingdom of Solmeria" shall be construed as a reference to the Constitution of the Kingdom of Solmeria. Where prior decrees reference specific articles or sections of the prior Constitution, those references shall be read as referring to the equivalent provisions of the Constitution of the Kingdom of Solmeria. Where no direct equivalent exists, the Constitution of the Kingdom of Solmeria governs by its general framework.

ARTICLE V — ROYAL ASSENT

This Decree is issued on 2026-06-28 under the full sovereign authority and seal of the Monarch of Solmeria, and takes effect immediately upon issuance in accordance with Article X, Section 1 of the Constitution of the Kingdom of Solmeria.
