#### RESEARCH INTERESTS

My research focuses on racial discrimination as a chronic psychosocial stressor that heightens African Americans' risk for physical (e.g., cardiovascular disease; dysregulation of the autonomic nervous system) and mental (e.g., depression and anxiety) health concerns. I focus on: (1) elucidating whether racial discrimination is a distinct stressor for African Americans with physiological and psychological consequences that exceed those of non-race-related stressors, (2) explicating the mechanisms that underlie the associations between racial discrimination and deleterious outcomes, and (3) identifying person-related characteristics that serve as potential

protective or vulnerability factors (e.g., racial identity) in the context of racial discrimination. My current projects primarily focus on racial inequities in the carceral state and Black women's experiences with gendered racism.
