# Personal Injury Law



If you've hurt in a wreck in Texas and are looking to hire a San Antonio accident lawyer, you might be asking yourself, what is personal injury law? The general phrase encompasses a great deal, but can be summarized as the following.

Personal injury law is an area of the law that falls under the category of tort law. Tort law (which is named after the Latin word "tortus," or "twisted") is part of the civil justice system that covers losses, wrongs, or damages that are caused by the conduct, act or omission of one party to another party's body, property, rights, or reputation.

The three major categories of torts are intentional torts, negligent torts, and strict liability torts. Within these categories, there are dozens of specific torts, including battery, assault, malpractice, defamation, trespass, and intentional infliction of emotional distress (just to name a few). Tort law differs from criminal law in many ways; namely, tort lawsuits have a much lower burden of proof and can be brought against someone who was acting negligently. Personal injury attorneys serving San Antonio are specialized lawyers who understand the ins and outs of the complex world of tort law, focused within the state of Texas. You may be asking, what exactly qualifies as a personal injury? Well, the term "personal injury" legally refers to an injury of the body, mind, or emotional state of a person. Personal injuries are separate from injuries to property and can occur in
