Interim Removal Type

Two types of removals are reflected in the following data:

- Unilateral removal to an interim alternative educational setting by school personnel (not the IEP team) for drugs, weapons, or serious bodily injury.
- Removal to an interim alternative educational setting based on a hearing officer finding that there is substantial likelihood of injury to the child or others.
