## Epidemic Sound vs. Artlist: Price and Subscription Options

As we all know, the price of a subscription can make or break your decision. Epidemic Sound offers a personal plan (the cheapest one) for \$15 per month or \$108 per year (\$9 per month) and a commercial plan for \$49 per month or \$228 per year (\$19 per month).

Artlist offers a starter Personal monthly subscription for \$14.99 or a yearly subscription for \$120 (\$9.99 per month). For commercial accounts, Artlist only offers yearly plans:

Music plan - \$199 per year (\$16.60 per month) and Music and Sound Effects plan - \$299 per year (\$25 per month).

Winner for Personal Plan: Epidemic Sound

Epidemic Sound wins for personal plans because it covers more platforms.

Winner for Commercial Plan: Artlist

Artlist wins for commercial plans because it covers broadcasting and TV and has no restriction on the number of accounts per platform (Epidemic Sound limits accounts per platform to 3 on commercial plans).

If you prefer a monthly commitment, Epidemic Sound might be more up your alley, otherwise, you might want to look into Artlist.

## Epidemic Sound vs. Artlist: Library Comparison

What about the library? How does Artlist compare with Epidemic Sound?

Epidemic Sound boasts an extensive library of over 35,000 tracks and 90,000 sound effects. Artlist has a smaller library of 18,000 tracks songs and 11,000 sound effects (and it's rapidly growing).

In terms of quality, both platforms offer an excellent selection of tracks from various genres, making it difficult to declare a clear winner.

Both sites add new music regularly. If you're anything like me, you'll find that having a vast library to choose from is essential for finding that perfect track.

However, if quantity is a priority, Epidemic Sound takes the cake.

## Epidemic Sound vs. Artlist: Licensing and Usage

The licensing models of Epidemic Sound and Artlist vary slightly. Both offer royalty-free tracks for content creators. Epidemic Sound's licenses cover a range of uses, from YouTube videos to podcasts and even commercial projects. Artlist licenses are similarly flexible, allowing unlimited usage across various media. As long as you maintain an active subscription, you can use their tracks without worrying about copyright issues.

With Epidemic Sound, you get also buy a single-track license, meaning you can use the track in any way that makes sense for you. The price varies from \$99 to \$499 depending on the use case.

Artlist is a winner in this category if you want to broadcast or produce films and movies.

Epidemic Sound is a winner in the personal license if you want to produce content for platforms that are not included in Artlist's license.

## Epidemic Sound vs. Artlist: Which One Offers Royalty-Free Music?

Both Epidemic Sound and Artlist offer royalty-free tracks. This means that, as long as you have an active subscription, you can use their music without any legal problems or additional fees (no royalties). You won't have to worry about copyright issues as long as you follow their licensing terms.

### Epidemic Sound vs. Artlist: User Experience

As a creator, you want a platform that is easy to navigate and offers user-friendly search filters. In my opinion, both Epidemic Sound and Artlist excel in this area. Their

interfaces are intuitive, with advanced filtering options to help you find the perfect song. However, some users find Artlist's interface to be slightly more modern and visually appealing. In my experience, Artlist's platform is more polished and easier to navigate. Epidemic Sound's interface is also user-friendly and offers a similarly robust search functionality.

Both platforms provide search filters that help you narrow down your choices by genre, mood, and themes. Artlist has an extra filter for the instrument.

## Epidemic Sound vs Artlist: Customer Complaints

Artlist Rating: 4.2 (based on 310 reviews)

Users complaints about Artlist include:

**Untrustworthy practices:** Some customers feel that Artlist did not honor free trials and charged for services they did not request.

**Licensing issues**: Some customers have received emails claiming that Artlist's assets are not legally licensed, causing concerns about using the content in their projects.

**Poor customer support:** Some users report slow response times and unresolved problems when contacting Artlist's support.

## What Happens After You Cancel an Epidemic Sound or Artlist Subscription?

If you cancel your Epidemic Sound and Artlist subscription, you can no longer use their tracks in new projects. However, any projects published during your subscription period are covered forever.

Any videos uploaded during your active subscription will still be covered, but new uploads after cancellation will not be protected by their license.

### Is Epidemic Sound Unlimited?

Yes, with an active Epidemic Sound subscription, users can access and download an unlimited number of tracks and sound effects from their library.

Please keep in mind (and this applies to Artlist and Epidemic Sound) that it is against TOS to scrape content or use bots to download tracks and sound effects from both websites. Companies have a right to suspend user's account if they see suspicious activity on them.

### Is Artlist Unlimited?

Yes, with an active Artlist subscription, users can access and download an unlimited "reasonable" number of tracks and sound effects from their library. In reality, "reasonable" means that users are limited to downloading 40 music tracks per day and 100 sound effects to justify fair use. For most creators, that is more than enough downloads per day.

## Epidemic Sound vs. Artlist: Free Trial And Refunds

### **Epidemic Sound: A Generous Trial Period**

Epidemic Sound offers a 30-day trial, granting unlimited access to their extensive library of music and sound effects. During this period, you're free to publish your work without worrying about additional licensing fees. If you find Epidemic Sound to be the perfect fit, the trial will automatically renew with the agreed-upon monthly price. However, be aware that if you forget to cancel, any charges incurred are non-refundable. Thankfully, canceling your subscription is a hassle-free process.

### Artlist: Limited Trial, Strict Refund Policy

Unlike Epidemic Sound, Artlist does not offer a traditional free trial. Instead, you can create an account, browse their library, and download watermarked tracks. To access their full range of services, you'll need to subscribe. Artlist does provide a refund policy, but it comes with stringent conditions. You can request a refund within 14 days of purchase, but only if no assets have been downloaded or used in a project. In other words, if you download even a single track, you forfeit your eligibility for a refund.

## Verdict: Which One Is Better: Epidemic Sound or Artlist?

In terms of pricing, Epidemic Sound's personal plan is a winner, as it covers more platforms. Artlist wins for commercial plans, accommodating broadcasting and TV with no restrictions on the number of accounts per platform. If you're leaning towards a monthly commitment, Epidemic Sound might strike the right chord.

When comparing libraries, Epidemic Sound boasts a staggering 35,000 tracks and 90,000 sound effects, while Artlist offers a smaller collection of 18,000 songs and

11,000 sound effects. Quality-wise, both platforms are neck and neck, but if quantity matters, Epidemic Sound takes the prize.

Licensing and usage are fairly similar between the two platforms, but Epidemic Sound's single-track license may be more appealing if you need just one track. User experience-wise, both platforms are user-friendly, but Artlist's interface has a slight edge in modernity and visual appeal.

While both platforms offer royalty-free tracks, their ratings are mixed when it comes to customer experiences. Artlist has a 4.2 rating, with complaints about untrustworthy practices and licensing issues. Epidemic Sound, on the other hand, has a 4.1 rating, with users citing difficulties with the cancellation process and copyright claims. I haven't experienced any issues with either platform. I like both services but if I had to choose one, I would pick Epidemic Sound because of the larger library, better variety, licencing model, and a 30-day free trial.
