Engineer's Report

Karolina Cho, from Gewalt Hamilton, presented the MS 4 Program, counting towards public education requirements. The program helps to monitor the water cleanliness and waterways. Brian Wesolowski mentioned that we do not jet sewer lines, but it is in the permit, so we may need to address in the future or the IEPA requirements.

IEPA has reached out about more requirements for CSO communities, and Brian Wesolowski will provide more detail about possible compliance issues or responsibilities in the future.

Nicor has some work planned for next summer on Overlook, from Golf Road to west of Orchard Lane. Brian will be working with them on ensuring we do limit any work that they do given those areas were just rebuilt.
