VII. Open Floor

Overview: open floor for any other updates, items for discussion, etc.

1. Terrebonne Parish Consolidated Government is seeing an increase in unsheltered homelessness. They have a waiting list at the family shelter.
2. Vaccination updates for emergency shelters:
 - Louisiana Department of Health (LDH) has put homeless emergency shelter participants and staff in 1B Tier 2 of their roll out plan. There is no information on where outreach staff, drop-in center staff, or unsheltered participants fall in the vaccination plan.
 - The State is working on a plan to incentivize both staff and participants to say yes to vaccines including vaccine ambassadors, larger vaccination events, some form of incentive structure.
