



Workplace Risk Assessment & Prevention Policy

1. Policy Statement

ICDET (International Center for Development of Education and Training) is dedicated to maintaining a safe, healthy, and inclusive environment for all individuals engaged in our projects, programs, and daily operations.

This **Workplace Risk Assessment & Prevention Policy** defines how ICDET systematically identifies, evaluates, and prevents risks across **THE SPACE (Physical Hub)**, **THE SPACE Centre (School Hub)**, **Accommodation Facilities**, **External Sites**, and all **ICDET-led activities**.

The policy is aligned with:

- **Bulgarian Occupational Health & Safety legislation.**
 - **European safety directives.**
 - **Erasmus+ and European Solidarity Corps (ESC) standards.**
 - ICDET's internal **Code of Conduct**, **Transparency Framework**, and **Duty of Care Policy**.

2. Objectives

- To centralise the **identification of risks** across all ICDET spaces and activities.
 - To **evaluate and classify risks** using a standardised risk matrix.
 - To establish clear **preventive and protective measures** for all identified risks.
 - To define **responsibilities** for staff, coordinators, and participants.
 - To create a culture of **safety, accountability, and continuous improvement**.

3. Scope

This policy applies to all **locations** and **activities** connected to ICDET.

A) Locations

1. THE SPACE (Physical Hub – LABs & ZONES)

LABs – Learning Through Practice

- **IT LAB** – Coding, software development, cybersecurity.
- **TECH LAB** – Electronics, engineering, applied technology.
- **DESIGN LAB** – Product design, 3D prototyping, printing.
- **ART LAB** – Arts, creativity, storytelling, cultural innovation.
- **AERO LAB** – Aerospace projects, drones, aeronautics.
- **MED LAB** – Health projects, diagnostics, medical prevention.
- **ROBO LAB** – Robotics, AI, automation.
- **PROD LAB** – Professional media production (audio, video, digital storytelling).
- **CONS LAB** – Architecture, sustainable construction, urban planning.
- **SENS LAB** – Sensory environments to enhance inclusivity and empathy.

ZONEs – Expanding Learning Horizons

- **GEO Zone** – Geography, mapping, drones, field studies.
 - **BIO Zone** – Biology, biodiversity, environment.
 - **NUTRI Zone** – Nutrition, food innovation, healthy living.
 - **WELLNESS Zone** – Sports, martial arts, yoga, resilience training.
 - **CULTURE Zone** – Intercultural exchange, traditions, languages.
 - **WELLBEING Zone** – Mental health, emotional growth, stress management.
 - **XR Zone** – Virtual/augmented reality, immersive learning.

2. THE SPACE Center (School Hub)

- Classrooms, IT & language labs, sports halls, libraries, cafeterias.
 - Operates under the **school's Risk Assessment & Prevention framework**.
 - ICDET ensures complementary measures for its volunteers, trainees, and mobility participants.

3. Accommodation Facilities

- Apartments for volunteers and trainees.
 - **Double and triple rooms, shared kitchenettes, and communal areas.**
 - Covered by ICDET's **Housing Rules & Safety Guidelines**.
-

4. External Sites

- **Event Venues** – conferences, trainings, cultural venues.
 - **Partner Institutions** – NGOs, schools, universities, municipalities, companies.
 - **Mobility Destinations** – local, national, and international sites.
 - At external sites, **host/venue rules apply first**; ICDET ensures alignment, pre-briefings, and insurance coverage.

B) Activities

This policy applies to all ICDET activities, including:

- **Erasmus+ mobilities** (learners, staff, VET).
 - **ESC volunteering and internships/traineeships.**
 - **Training courses, workshops, seminars, hackathons.**
 - **Youth exchanges and blended mobility.**
 - **Cultural activities** (media productions, cooking events).
 - **Sports, wellness, and outdoor education.**
 - **Community events, conferences, public activities.**
 - **Hybrid and online activities.**

4. Methodology

ICDET applies a **systematic four-step cycle**:

1. **Hazard Identification**
 - Inspections of labs, zones, accommodation, and activity venues.

- Staff, volunteer, and participant feedback.
- Analysis of past incidents.

2. Risk Evaluation

- **Likelihood:** Rare / Possible / Likely.
- **Impact:** Minor / Moderate / Severe.
- **Risk Level:** Low / Medium / High.

3. Prevention & Control Measures

- Elimination (remove hazard).
- Substitution (replace hazard with safer option).
- Engineering controls (fire alarms, cable covers, ergonomic furniture).
- Administrative controls (policies, rules, schedules).
- Personal measures (mentorship, PPE, behavior guidelines).

4. Monitoring & Review

- Annual reviews by ICDET Safety Officer.
- Quarterly checks in THE SPACE and accommodation.
- Post-activity reviews after mobilities and events.
- Immediate update after incidents.

5. Risk Categories by Location

A) THE SPACE – LABs

- **IT LAB:** risks of long screen exposure, cyber threats → prevention: ergonomic setups, cybersecurity rules.

- **TECH LAB:** electrical shock, soldering burns → PPE, tool training, shut-off switches.
 - **DESIGN LAB:** 3D printer burns, fumes → ventilation, goggles, gloves.
 - **ART LAB:** paint/chemical exposure → non-toxic materials, ventilation.
 - **AERO LAB:** drone crashes, battery hazards → goggles, restricted flight zones, handling protocols.
 - **MED LAB:** biohazards, equipment misuse → hygiene rules, simulations only.
 - **ROBO LAB:** robotic arm injury → safety shields, emergency stop.
 - **PROD LAB:** heavy equipment, tripping → cable covers, tripod use.
 - **CONS LAB:** sharp tools, dust → masks, safe workspace checks.
 - **SENS LAB:** sensory overload → supervised use, calming protocols.

B) THE SPACE – ZONES

- **GEO Zone:** outdoor accidents → safety briefing, drone limits.
 - **BIO Zone:** specimen handling risks → gloves, hygiene.
 - **NUTRI Zone:** cuts, burns, hygiene → supervision, food safety checks.
 - **WELLNESS Zone:** sports injuries → warm-ups, professional trainers.
 - **CULTURE Zone:** intercultural tension → mediation, facilitation.
 - **WELLBEING Zone:** emotional stress → safe space, confidentiality.
 - **XR Zone:** dizziness, falls → time limits, cleared floor.

C) THE SPACE Center

- Risks managed by school framework (fire, sports, labs).

- ICDET ensures intercultural mediation, mobility briefings, and participant safety support.

D) Accommodation Facilities

- **Rooms:** overcrowding, fire risk → evacuation maps, electrical checks.
- **Kitchenettes:** burns, food hygiene → cooking rules, cleanliness inspections.
- **Communal Areas:** conflicts, stress → house rules, quiet hours, mediation.

E) External Sites

- **Event Venues:** overcrowding, fire → follow venue plans, pre-event check.
- **Partner Institutions:** school/NGO risks → comply with host policies, ICDET oversight.
- **Mobility Destinations:** travel accidents, theft → travel insurance, safety briefings, secure housing.

7. Emergency Procedures

- **Evacuation plans** displayed in all spaces.
 - **First aid kits** in every LAB, ZONE, apartment, and external activity.
 - **Trained first aiders** in each location.
 - **Emergency contacts** distributed to all participants.
 - **Incident reporting system:** incident → immediate response → written report → Safety Officer review → updated measures.

8. Monitoring & Review

- Annual review by the Safety Officer.
 - Quarterly inspections in THE SPACE and housing.
 - Safety briefings before all external events/mobilities.
 - Feedback loops with participants and staff.
-

9. Publication & Access

- **Safety & Compliance Desk (Public Access)**

- Published as a **PDF** for transparency with partners, stakeholders, and participants.
- **Crew Access → Safety Station (Internal Use)**
 - Editable version
 - Includes Risk Register, reporting templates, inspection logs.
