## **Previous consultation ( closed April 2023)**

As part of your child's educational experience, we are committed to promoting the health and well-being of our pupils. In our diverse society, children need to develop an understanding of themselves, others and their community and how we can work together in harmony. They also need to know how to maintain healthy lifestyles and relationships with others.

As you may already be aware, the Department for Education has announced changes to relationships and sex education following nationwide consultation. These changes came into effect from September 2021 and all schools will are required to comply with the updated requirements. The statutory guidance can be found at:

The guidance focuses on healthy relationships and keeping children safe in the modern world. It also covers a wide range of topics relating to physical and mental health, well-being, safeguarding and healthy relationships. Learning about the emotional, social and physical aspects of growing up will give children and young people the information, skills and positive values to have safe, fulfilling relationships and help them take responsibility for their own well-being.

As a school, we have already been teaching RSE (through our Health and Relationships Education) and we have a comprehensive curriculum in place. However, we thought that this would be a good opportunity to review our RSE curriculum and policy so we can be sure our RSE provision is appropriate for our pupils based on their:

- Age
- Physical and emotional maturity
- Religious and cultural backgrounds
- Special educational needs and disabilities

Whilst we are sure that there will be differences of opinion about this, we hope that consulting with you will help to inform our school's decisions and enable us to reach a consensus.
