Little Sister's Book & Art Emporium is a GLBT bookstore, adult store, and unofficial community centre. It is located at 1238 Davie Street, in the heart of the West End between Jervis and Bute.

The closest transit available is the #6 bus (connect from Expo/Millenium lines at Granville Station) or the C23 shuttle bus (connect from Canada Line at Yaletown-Roundhouse). Eastbound bus stop is less than half a block away; Westbound is across the street.

Both the main space and the public washroom are *mostly* accessible to chairs and scooters. There may be heavy doors or tight turns interfering with smooth navigation.

Staff are helpful and community-oriented in nature, but do not have formal training in accessibility issues.

Each staff member has their own individual background in community involvement and knowledge.

There is no scent policy in place at the store. Be aware that the bathroom is sometimes very heavily scented.
