# Privacy Policy

#### Information We Collect

Our tendency is not to collect your personal and non-personal information. All permissions that are requested are for application performance. Then again, it might happen that we collect the previously mentioned information once you communicate with us. This will happen solely in the situation when you contact us via mail which is listed on the bottom of this Privacy Policy. We can guarantee that your e-mail will not be misused, forwarded nor used in any way. Nevertheless, it is out of our reach whether the third parties who display interest-based ads will gather and use your personal information. We are therefore not responsible for the actions taken by those companies and people, for the possible content of their sites and also the use of the information you provide to them. With using our Services you are agreeing to our Policy that is explained here.

#### Third Parties Services

Our intention is to enable you free high quality apps and games that will make your day. With that in mind we cooperate with a few providers who are allowed to display interest-based ads. However, the connection to those sites does not signify our sponsorship of those companies nor affiliation with those people. By accepting our Services and using our apps without selecting opt-out options you are giving us your consent to transfer the data as stated. For iOS 7 or higher

Settings > Select Privacy > Select Advertising > Enable the "Limit Ad Tracking" setting

For iOS 6

Settings > Select General > Select About > Select Advertising > Enable the "Limit Ads Tracking" setting

For Android with OS 2.2 and up and Google Play Services version 4.0 and up:

Open your Google Settings app > Ads > Enable "Opt Out of Interest-Based Advertising"
