Questions & Notes About Other Colleges

Knox College (posted on admissions website <http://bit.ly/1aPJerb> on Nov. 1) “If you're a student, counselor, or teacher trying to submit application materials for our November 1 Early Action application deadline, don't panic! Submit your documents as soon as possible, and we will honor all requests to be considered as an Early Action I candidate.”

Brown University is not officially extending its early decision deadline at this time (Oct. 25) but has emailed applicants and posted on its website that it will offer extended deadlines on a case by case basis to students facing problems submitting the Common Application. Students need to email Brown admissions if they need extra time. See <http://bit.ly/1ae5yyg>

Skidmore College is not extending its early decision deadline at this time (Oct. 26) but is monitoring the situation with the Common App closely and may extend deadlines if warranted. Students and counselors should check their website for updates <http://bit.ly/1cjrRUL>

Christopher Newport University - is not extending its early decision or early action deadlines officially but will offer an extension to students and school officials if they email the university to explain that they're having problems with the Common Application. <http://bit.ly/1ePUw16>

Middlebury College - not extending deadline at this time but will be flexible if students have trouble submitting their applications by the Nov. 1 deadline. They are encouraging counselors and teachers to email their letters of recommendation and school forms if they're unable to submit them through the Common Application. <http://bit.ly/1gHernq>

Seton Hall University is waiving its application fee on its own application to encourage students to switch from Common App to the university's application <http://bit.ly/1bYuZkR>

Saint Thomas Aquinas College is not extending its deadlines at this time (Oct 24) but suggests students who can't get the CA to work contact admissions and the college as soon as possible and they will send a paper application for students to fill out.
