USER SCENARIOS

BUYER

Ini is thinking about buying a camera, having seen a demo on a seller's wall on twitter, but she's unsure of the seller's credibility. She downloads the app, now available fortunately, as she thinks about buying the camera. In it she can easily sit back and invite the seller to the app by creating a link and sending it to the sellers phone number or email, she can as well copy the link created and send it to the seller's social media messaging platforms. The seller clicks on the link and he or she is redirected to EXQURE app in order to set down the rules of their transactions and conditions of sale. Ini makes the payment of the agreed amount and commission to the now available EXQURE account.

When her camera has been successfully delivered and her expectations have been met, she then releases the fund by authorizing payment to the seller by EXQURE.

Thanks to reviews and ratings of each seller, she can see the credibility of sellers and what other buyers are saying. This browsing experience was quite pleasant, and the Transaction went satisfactorily.

SELLER/ BUSINESS OWNER

Tosin advertised his product on instagram, but has been having trouble with buyers' trust due to frequent lack of customer satisfaction. He comes online to find a way to solve his customers' concerns his came across EXQURE. Tosin signed up on the app and invited his customer to assure them of his credibility and confidence.

His customer clicked on the invitation link and signs up to EXQURE and agreed to the terms and condition of sales, the buyer pays the total amount agreed to EXQURE account and Tosin gets a notification of the payment.



At the end of the day the customer is happy and Tosin is happy too.


