Well, instead of having an end date, can we have a-- because I don't want to at the end of 12 months not use it anymore. Could we go until we have another conference like this?

Wendy Morkel:

Okay.
Jennifer Willis: Could we say something that in 12 months we're gonna have more final vote on it? If we don't have a conference in 15 months <inaudible></inaudible>
Wendy Morkel: Okay.
Jennifer Willis: Until the next conference so that we can vote on it either way?
Wendy Morkel: Okay. So trial till the next women's conference? Is that what you're saying?
Jennifer Willis: <inaudible>.</inaudible>

Okay. Yeah.

Whitney Horning:

So the vote that just happened was a majority. So how is what's proposed next different? Because now you're breaking it down to different things. The majority just voted to accept it and make modifications.

Wendy Morkel:

Yes.

Whitney Horning:

It's getting a little confusing

Wendy Morkel:

It is getting confusing. I agree.

Whitney Horning:

It's the majority then that just got decided, and now we are going forward

Wendy Morkel:

Okay. And the idea was that we would be... we are voting to vote. We have not conducted the official vote yet. Is that how everyone else understands it? Was I clear about that?

Women:

[Confused Murmurs]

Wendy Morkel:

I was not clear about that. Okay. Okay. So yeah, this is a vote. Do we want to vote on these things? Do we want--so it sounds like we want to vote on: One, adopt this for 12 months. Two, adopt this for 12 months and understand that we can make modifications to it. Too, do we want to vote on adopting this just straight up. And with the caveat that we are going to workshop making modifications on it. Three.

Then subsection i. would be, "women must notify the accused of the specific charges before the council begins," so we're adding the word "first" to the end sentence and changing the order so it kind of outlines the--

Wendy Morkel:

Okay. So first notify law enforcement, then inform the accused of the charges. Okay. Any-- Are you motioning or are you seconding?

Woman:

I'll motion.

Wendy Morkel:

Motion. Okay. Second for that?

Woman:

Second.

Wendy Morkel:

Okay. All in--

Kami:

<inaudible>

Wendy Morkel:

Okay. I will get to your question next. All in favor of that change to switch those two. Okay. And any opposed? Okay. Kami had a motion, I think.

Kami:

Yeah, I feel confused about what we're doing right now, but I propose... I guess I'm proposing a motion to be voted on today. That's what I'm doing. I think it doesn't have to do with the document though, specifically. But my proposal is that we have a place on the website where we can make proposals like "add this word," "define this word," or "here are some scriptures I think we ought to add to our list of recommended reading," or whatever we want to call it. So that we can sit and talk about this as we move between now and the next conference. So we can work

It would be basically proposals for the next conference in 12 months.

Wendy Morkel:

Okay.

Kami:

So we wouldn't--

Wendy Morkel:

Okay. Okay.

Kami:

We wouldn't vote until next year, whatever we decide. But we can sit and talk back and forth, you know, write it out, say, here's the scripture I'm looking at. Here's what I think it's saying, here's how this would affect the women's council.

Wendy Morkel:

Okay. Okay. So what I'm hearing is Kami is motioning to make a section of the website for discussion, which is really for proposals for the next conference, proposals for items to be addressed or voted on. Is that correct?

Kami:

I believe so.

Wendy Morkel:

Okay. Does anyone second this motion?

Woman:

Sure.

Wendy Morkel:

Okay. I see some seconds. All in favor of this, of voting on this? Okay. I see some folks, yes. Okay. Okay. I can't tell if that's a majority. How many are not in favor? Okay. There are, okay. I'm gonna have to count here because I don't, okay. How, keep your hands up if you're not in favor.

Woman:

And to clarify, we're saying table the voting today and then create a space <inaudible>

Wendy Morkel:

Okay. I don't think "table the voting" is on. I think all Kami wants is a space on the website to submit proposals and discussion to be addressed at the following conference so that we are not going in blind next time. Is that right? Okay. Okay. So is that, with that clarity, all in favor of voting on that?

Woman:

I think that would be a huge contention.

Wendy Morkel:

A huge contingent?

Women:

Contention.

Wendy Morkel:

Oh, a huge contention. Okay. Okay. So are you not in favor then?

Woman:

Can someone speak against, and tell us the reasoning?

Woman:

Yeah

Wendy Morkel:

Okay. Yeah.

Heidi Fargo:

I think this has been beautiful, and when we're face to face and we're working together, there is a spirit. I'm thinking of a lot of things where there's a good spirit, and you go away and you get online and you're just a keyboard person, and it changes. And I just think there is wisdom in being face-to-face and not debating things on black-and-white screens.

Wendy Morkel:

Well, I agree. I would even go so far to say as speaking with you all here instead of on Zoom... Huge difference there as well. Yeah, Kami.

Kami:

I wasn't thinking so much like a chat or forum, just a place where we could put our proposal so people can look at it and think about it in advance.

Woman:

Make a list.

Wendy Morkel:

Okay. Make a list of what, what you would like to address. Yes. I think this is...

Woman:

So if we're gonna try to do the process, let's practice and see how this works, when we come back together can we look at okay maybe we need to change this wording, you know, at that point, then we can possibly change the writing and put something on the website.

Wendy Morkel:

Okay. So prior to the next conference, instead of, so this is a counter-proposal, instead of putting something on the website to have discussion over the next 12 months, it will be at some point in anticipation of the next conference. Is that correct?

Woman:

Well, ya you could. After you worked with it <inaudible>

Wendy Morkel:

Okay.

Woman:

Under this situation, the wording could be changed.

Wendy Morkel:

Okay. Okay. So yes. So we're talking about two different things here on Kami. So Kami's, I was lost on whether we had a majority vote. Can we have it again, who are in favor of having a place for over the next 12 months to submit proposals? Okay. Okay. Yeah. And who is not in favor of that? Oh, that really looks like a majority that is not in favor of that. Can I count you, just to be sure? Yeah. Okay. One, two, three, four, five, six, seven 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13,14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27. I believe that's 27. Who was--how many were in favor? Raise your hands if you're in favor. 1, 2, 3, 4, 5, 6. I swear, I saw more hands. Wait, keep your hands up. 1, 2, 3, 4, 5, 6, 7, 8. I only see eight hands. Okay. It looks like the majority is not in favor of that at this time. Yes, Heidi?

Heidi Farqo:

I think kind of the pattern you did is here for a reason. People send in their proposals to a person, and then those are also made available, like you said, for the conference.

Wendy Morkel:

Okay. Okay. So something similar, but it's made, maybe it's made available farther in advance. What do we think about that? That you submit proposals that are made available on a website

farther in advance. And I will say, I do not have plans to chair the next conference. So if you vote on this, whoever, this is somebody else's responsibility, probably.

Whitney Horning:

How about Stephanie?

Wendy Morkel:

<Laugh>? Any seconds for having a website to propose, make proposals? I don't even know if this is something we need to vote on, but sure. Seconds on having a website to make proposals on in anticipation of the next conference. Okay, a second. Okay. How many in favor of that? Nobody, nobody is in favor of that. Okay. You know what, I think that's something to work out before the next conference. Okay, so what I have here, oh--

Stephanie Snuffer:

I have a motion.

Wendy Morkel:

Oh, yeah--

Stephanie Snuffer:

I'm going to, sorry. I'm sorry.

Wendy Morkel:

No, thank you.

Stephanie Snuffer:

Okay, I'm gonna try and articulate this the best I can. My motion is that we trial this for 12 months with all of the caveats. Okay? So table 12 had a lot of really good concerns that were relevant to many of their experiences that will be relevant to you guys. And you don't even have to know what they are, right? Because they're their concerns. Which means if we're trialing it for 12 months, that also allows--Rachel, I don't know what table you are--but that allows your table to really process the document. Think about it, write your thoughts about it, gather how you feel about it. And you know, heaven forbid you don't have to engage in a council. So you have this time to do the thinking and the processing and the praying that you want to do. Okay? So what I'm hoping my proposal or my motion might facilitate is 12 months as is "-ish." easily flip the phrasing on that, right? So as is with the discussion that's gone on here, okay? And I've taken notes, I will fix everything that I can fix so that whatever new document you see will, to the best of my ability, reflect what is easily changed in this moment. And then nobody is bound by it because it is the trial that you all want to engage in. Does that feel okay? So my motion is that we take a 12 month trial. Wendy Morkel: Table 13. Lucky number 13. To only list it at the fellowship's discretion if they want to list the initials on the website or yeah. We haven't even decided what website yet, so we're gonna just have to figure it out. If you want to use our Women of Peace one, you are totally welcome to. We can just keep it up. Uh, yeah. Marilyn.
Marilyn: <inaudible></inaudible>
Wendy Morkel: Okay. Counter proposal. We were almost done. Yeah. No, you're good. You're good. You're good.
Marilyn:

So I would like to see, like, we have the Baptism clearinghouse, something like that where the certificates are uploaded so that you have the women that have signed it from whenever <inaudible>. Then, if it's ever recanted, then you can put a date in there. If it was reinstated, date there. So that everything's in one place. If a man loses his certificate we can go back because it's uploaded on a website.

Stephanie Snuffer:

Okay.

Wendy Morkel:

Okay.

Stephanie Snuffer:

Well, time out Karen. Karen, hold on. Karen, I'm just gonna speak to the-- as far as the initials, and again, this is fellowship autonomy, right? I don't care. I mean, that's fine. If fellowships do not see that it rises to the need of recording it anywhere. I don't think, that's not scriptural. It's not, it's just kind of one of those things. So I don't care about that. Now as far as the other proposals, I'm not gonna get involved in that.

Wendy Morkel:

Okay. Okay. So this is a proposal to have a database where all priesthood certificates are uploaded. And Karen has a comment, and I think I saw some other hands. Jennifer also has a comment.

Karen Strong:

It's adding too much. Look... we don't even put baptisms what are... We don't--you do not put people's names out there. We do not want to be putting every man that has their certificate and the women who have signed it and all that kind of stuff. That is just getting too far. And the only way that Stephanie's work was just an initial thing on the discretion of the fellowship. It really would only be, in my opinion, like the man is maybe a danger, and we know he is fellowship hopping and is doing things and is not repentant. In general.

Wendy Morkel:

Yeah. I think--

Karen Strong:

I just don't think putting a priesthood certificate having a general thing where we're announcing this man has a certificate and we're the seven women connected to it.

Wendy Morkel:

Yeah. I feel like what Karen's saying is that a key difference with the baptisms being recorded--We can't all see that. And Yeah. And with the certificates being uploaded, we're hearing that that would be a database that people could access someone else's certificate. And so I personally, and I don't wanna make decisions for the group, but I do feel like this is a very big discussion that we are having right at the end of the meeting. Yes. Jennifer.

Woman:

Can we vote to table that?

Wendy Morkel:

Table it. Okay. Yeah. Jennifer had one comment and then we'll vote whether or not to table that or vote on it.

Jennifer Willis:

<inaudible> If any of you feel inclined to rise up and do something <inaudible>

Wendy Morkel:

Okay.

Jennifer Willis:

<inaudible> the foundation of our country was laid over many hours of <inaudible>

Stephanie Snuffer:

Gosh, I'm not, I'm actually not listening. I'm so sorry. I'm not listening.

Jennifer Willis:

<inaudible> I think it is very needed, especially over the next year. We didn't even get through <inaudible>

Wendy Morkel:

I know. Yeah. Yeah.

Jennifer Willis:

<inaudible>

Wendy Morkel:

Okay. Okay. I wanna reiterate what Jennifer just said. She says this is not a motion, she just wanted to put it out there. She wanted to make the suggestion that there are many, many things that women have questions about that we did not even come close to talking about, like, what does daily walk mean? Like Marilyn just presented how, what are the pros and cons of having a database for priesthood certificates? So what Jennifer's proposing, as not an official proposal, is if someone wants to organize another one of these at any point, not necessarily 12 months from now, could be earlier than that. She definitely will attend. And I would hope that, it looks like there is a lot of enthusiasm for this, and I really appreciate everyone's enthusiasm. And did I get that right, Jennifer? Okay. Awesome. Okay. Motion to--we'll table Marilyn's suggestion. I feel like I'm overstepping by saying that, but do we want to table that idea? I think it is a valid idea. I just

know that there's a lot of feelings on both sides, well not feelings, but there's a lot of arguments on both sides. Yeah...

woman:

I think that maybe we should <inaudible>.

Wendy Morkel:

Okay. Okay. Okay. so are we a vote to table that for the next conference? Yeah. Okay. Second. All in favor? Okay. Any opposed and wanna vote on it right now? Okay. Okay. Any other concerns or should we get to our closing?

Stephanie Snuffer:

No, I think I might have a concern.

Wendy Morkel:

Oh, okay. Stephanie has a concern.

Stephanie Snuffer:

I think I might have a concern. Sorry.

Wendy Morkel:

Do you need to come up to the mic?

Stephanie Snuffer:

I might, I may not have been clear. Well, thank you Kalisa for making whatever I said unclear. I don't think she heard me. Okay. My motion: I need to clarify my motion and you can help me out here. Okay. So my motion was to take the document. Let's just start as is just for a minute. Let's just start as is. Oh, sorry. Take the document as is. I might pare it down in a minute, as is and vote to use it as a trial. So it's got some things in it we don't like, it's got some things in it I can change very quickly that are meaningful and yet meaningless. Right? I can change the sentence wording of one. I wrote everything down. But there are really, really only one or two things that I can change quickly in this document.

Like on number four, who can petition? I can obviously put that in as a clarification, man can petition seven of 12 women return it. I think table... whatever that table was, had a little bit of an issue with--what if we can't gather back the same seven women? Do we have the flexibility to find another seventh woman? I think I can add that. Okay. Now I'm not gonna go through everything, but do you get my gist? Do you understand what I'm saying? Yeah. Okay. Table 12 had a lot of really genuine, thoughtful concerns. I can't do anything about those right now. Right? I can't, I can't just full-scale change the idea about anonymous councils because we haven't talked about it or voted on it. So I'm not gonna do anything with those things. Those deeper concerns that need to be talked about or need to be experienced in, you know, in either councils or among fellowships and stuff. So, document as is with changes that can be made

immediately that do not, I don't know what to say... Kalisa, help me. Am I on the right track, though?

Kalisa:

Yeah.

Stephanie Snuffer:

In addressing your concerns. Kalisa.

Kalisa:

Okay. So the concern was, I felt like you voted on that Steph was gonna incorporate all of the changes that were suggested by each table. But we have conflicting concerns. And so how do you make quick changes?

Stephanie Snuffer:

Well, okay, for example, "convene." Marin asked what "convene" meant: before or after. I mean that's an easy--all I have to do is put a clarifier in there right before <laugh>, right? I can just do "before." And that fixes that one. Does that make...?

Woman:

It sounded like your answer was at the beginning of the meeting because "before" could be like, while you are planning the thing.

Stephanie Snuffer:

Well, yes, but my point is, is all that takes is a clause to clarify. It's not a disputed issue, it's a confusion. I can fix a confusion, right? I can fix a--you know--where I put a question mark and someone has, you know, you've all gotten up and agreed that seven women--you know--I can fix those things. Those are not for me to decide. Those are for you to decide. Am I clarifying things in a way that helps? Okay. So please bear with me. I am going to document "as is with changes that are not disputes or discussions."

Clarifications.

Clarifications. Okay. Twelve-month trial period. Jennifer [Willis], someone told me what you said, but how you guys decide to workshop this throughout the next year is up to you. Like, literally up to you. No vote. At least I don't think. Like no vote, no nothing. Like I said, you're welcome to email me. You're welcome to contact me. You're welcome to contact each other. We'll come back here in 12 months and, woohoo, do this again. And I expect to see every one of you plus

one. Okay. Did I-- Did that help? Okay. Do we need to revote or are we just good? Please tell me. We're just good. Oh, God. Thank you.

Okay. Should we sing and pray?

Yes.

Okay. And then any of you all who can stay? Ashley's meditation I know is gonna be amazing 'cause I've been to one of her meditations before. And I'll probably ask if those of you who aren't participating that you just, I know we're all also gonna wanna talk after this, but maybe if you could take that out in the hall so that it's quiet here. How does that sound? And let's sing. Oh, no, that's not what I'm looking for. There we go.
