The Mahjong Relax team highly values your privacy. This Privacy Policy outlines how we collect, use, and protect your personal data when you access, use, and play games, features, content, and services through mobile applications and other channels or portals.

- Information We Collect

- Advertising ID: Google Advertising ID ("GAID") on Android devices or Identifier for Advertisers ("IDFA") on iOS devices. The advertising ID is a resettable persistent identifier generated by Android or iOS, allowing online advertising companies to identify devices across apps for advertising purposes. For more information on how to limit our use of advertising IDs, please see "How to Control Information."

- IP address of the device.

- Unique IDs generated by our advertising partners for device identification.

- General technical information about the device, such as:

- Device type and language, operating system name and version.

- Device timezone.

- Internet connection type of the device (e.g., Wi-Fi).

- How We Use Collected Information

- We primarily use the collected information to provide services to players of our games.

Additionally, we use this information for the following purposes:

- Providing and improving our services.

- Analyzing how users use our services.

- Displaying and running in-app advertisements.

- Researching and analyzing the features and performance of the services and activities related to the services.

- We do not have access to information collected by SDKs.

- International Data Transfers

- Depending on the IT configuration of our website and mobile applications (which may be adjusted from time to time), we may choose to store your personal data on local servers or servers located abroad.

- If transferring your personal information to servers located abroad complies with applicable laws' definitions of international or cross-border data transfers, we will determine

the legal basis for the transfer and take appropriate security measures to ensure the protection level required by applicable laws.

- Data Retention

- We will only retain your personal information for a reasonable period necessary to achieve the purposes outlined in this policy. When your personal information is no longer needed to achieve the purposes outlined in this policy, we will delete or anonymize your personal information.

- Your Rights Regarding Personal Information Processing

- You may have certain legal rights related to the processing of your personal information, which may include:

- Right of access: You may request access to the personal information we hold.

- Right to rectification: If your personal information is inaccurate, you can request correction.

- Right to erasure: You can request us to delete your personal information.

- Right to restriction: You can request us to restrict the way we process your personal information.

- Right to data portability: You can request us to help you transfer your personal information to other entities.

- Right to withdraw consent: You can withdraw your consent at any time.

- Right to lodge a complaint: You have the right to lodge a complaint with relevant regulatory authorities.

- The above rights apply only in limited circumstances as provided by applicable laws, and if we decide not to respond to your claims regarding the above rights, we will explain the reasons.

- Children's Data

- Our services are designed and provided for users of different age groups. We do not collect any personal data from users under 13 years of age. If parents or legal guardians suspect that their children under the age of 13 have inadvertently provided personal information to us, they may request us to delete such personal information.

- Users aged between 13 and 18 years old (or the relevant age defined as minors in the corresponding jurisdiction) should obtain consent from their parents or legal guardians before using our services.
