Yeah two days ago, I had it I'm the first person that I know who's gotten it. So some people were asking me what that experience was like, and I, to be clear, I qualify for a third shot because of I take immunocompromising medication as many people do. And so I just went on the old cvs.com great website.

It's okay, not an official endorsement of cvs.com. Again, this was my experience. And they you can just self-register. And they tell you, they let you select whether you want Pfizer or Moderna, so you can choose which one.

And if you haven't gotten the vaccine, which if you haven't listened to this, if you're listening to this podcast and haven't gotten any vaccines, what are you doing, but also just go get one. So you can still choose which which vaccine you need. And then there was a box to check about, you know, whether you qualify based on you know, being immunocompromised for whatever reason. I would say probably get the same one. That's I think what they're advising also maybe talk to a medical professional.

Yeah, we're not. We're not that.

JENNY C. 04:29

It's just me sharing my experience. And it was fine. It went fine. I feel okay. I'm glad that I got it. Science is amazing. So yeah, there you go.

Yeah this is an endorsement for science. And we're we're pro science podcast. I think we've said this.

Yes, we report on science we don't claim to be experts on science.

I felt great.

JENNY C. 08:27

I don't know but Jenn has prepared for us another edition of Bad Jennifer.

JENN T. 08:34

Well I have a small update to that I went into this a clear eyes, full heart, Bad Jennifer and it turns out it's a Sad Jennifer.

JENNY C. 08:44

Oh no.

JENN T. 08:45

A little yeah, a lot even a little bit, a lot of it.

JENNY C. 08:48

A lot

JENN T. 08:49

Most of the time.

JENNY C. 08:49

You did tell me that you were going to read a 400 page book. Did that happen?

JENN T. 08:53

Well no it didn't because I downloaded a smaller book that felt very much like someone just like if BuzzFeed gifs had a book. I was like, What did I just read? I couldn't find anything on the author. It doesn't matter. I got the information. I read several newspaper articles. I went to our favorite murderpedia, so.

That is all that matters.

JENN T. 09:17

There's a lot and I watched some stuff and I'm okay.

JENNY C. 09:20

As a librarian, I support reading less than you have to, so.

JENN T. 09:26

Yeah I want you to be unemployed as well.

JENNY C. 09:28

I mean, no, there's just only so much time in the day. If you can get your information in less than 400 pages, then get your information. Do whatever you want.

I do want to read that because I really can't see how this person squeezed 496 pages out of this case but sure, so.

Alright let's do it. Sad Jennifer.

JENN T. 09:47

Sad Jennifer. So the sources are today.com March 1, 2007 - John Springer, The Mayo Clinic. And then here's the here's the this is gonna blow it. "Hiccup Girl Sues Over Photos in Ad," by the Tampa Bay Times November 17, 2009 - Robyn Mitchell.

JENNY C. 10:04

Oh shit it's the hiccup girl!

JENN T. 10:08

Yup! "Hiccup Girl: The True Story of Jennifer Mee," by Samantha Ryan a very mysterious author who I do suspect was self published. The Jennifer Mee episode of the Criminal Broads podcast and the book that I didn't read that I might read is "One Breath Away the Hiccup Girl from Media Darling to Convicted Killer," by M. William Phelps. And if you watch any sort of likeOxygen or ID you know this guy he's kind of broey. He's got like dyed blonde hair he's written I want to say 44 books about true crime that also feel very similar to Donald fielder and that they seem like adaptations of existing Oxygen or ID shows. Chicken, egg I don't know what comes first. Is he, did they get these shows from his books or did he somehow get 496 pages out of an hour of "Snapped"? Who can say? But if you Google to say, there's a lot to say 496 pages, but if you Google him, I bet you'd recognize them as a person who's regularly on these shows. And he's a host of one of them. So first, we're gonna start it's gonna get sad. Right away. I'm sorry. I'm laughing. I just started my period today also, so maybe that's in the mix as well. That's why I was so horny. We're all caught up all caught up. Okay, so she was born in Vermont, where her mother was a waitress and her stepfather was on benefits and I don't know what that means. Maybe disability

Probably disability.

JENN T. 11:32

Perhaps okay, because I've never heard it described as on benefits before. Jennifer Mee had four little sisters. They all shared a room very crowded. And eventually they were economically forced out of Vermont and decided to move to the much more affordable state of...would you like to guess?

California

JENN T. 11:57

Is California affordable? Florida!

JENNY C. 11:59

No, I was going opposite. I was thinking it's actually more on affordable Florida where only good things happen.

JENN T. 12:07

Yup nothing bad there. The Affordable State! Trigger warning, sexual assault. Unfortunately, before she was even 13 years old, Jennifer was repeatedly raped on a daily basis by two different men for about two years. I could not find anything about these men. It's awful. And I don't want to give them any of our time or our pieces of shit and covered in other pieces of shit.

JENNY C. 12:32

Absolutely. Fuck them.

JENN T. 12:34

And you're kind of and another trigger warning abuse. As a teenager she became pregnant by her then boyfriend who beat her so badly she miscarried. I told you sad. It's not it's not doesn't even get second to get any better. So because of all this as well as the sexual assault, Jennifer, of course suffered from depression and suicidal ideations.

JENNY C. 12:59

Yeah, that's what happens.

JENN T. 13:04

So now first, let's get into the hiccups. In, on January that I had no but did you know about this? Now I remember way back when we decided to do this podcast, I discovered this and we were like, Whoa, but I had not heard of the hiccup part. Had you?

JENNY C. 13:20

Uh well I mean. I remember...

JENN T. 13:22

This was 2007.

JENNY C. 13:24

No like, I didn't know when this when this happened. I don't think I was aware of it.

JENN T. 13:29

Not the hiccup story?

JENNY C. 13:30

I don't think so.

JENN T. 13:31

Okay, neither had I. And I'm trying to think of what, where were you do you think? Early January 2007.

JENNY C. 13:38

I was turning 22. And I was in my last year of college.

JENN T. 13:45

Okay I was I had just moved back home and life was fine. I think I was dating the kid. I've mentioned him before who had the gambling problem and would pee in the bottles because he didn't want to leave his computer. Sure. So I was doing great. You were 1007 great. Yeah. So Jennifer was 15 years old and suddenly out of the blue, I think it was in school she started hiccuping 50 times a minute.

JENNY C. 14:11

A minute. There's only 60 seconds in a minute.

JENN T. 14:14

Yeah

JENNY C. 14:14

I just did the math. That's almost one hiccup per second.

JENN T. 14:18

It, that's awful. I get upset when I when i usually I don't burp but I have a weird thing I call a hiccp or I do like this. I'm so sorry to everybody or I really go. [LOUD HICCUP NOISE]

JENNY C. 14:29

That sounds like you've seen a ghost and you're about to die.

JENN T. 14:31

I sound like I am the ghost and I have died. So that in those are always deeply painful. It's like my body's taking a very dramatic breath. So I don't know if every hiccup was like that, but it was like that 50 times a minute.

JENNY C. 14:36

That can't be good for your heart.

JENN T. 14:47

No, no.

JENNY C. 14:49

I'm no cardiologist but like that sounds just really painful.

JENN T. 14:52

Okay well this is the first time I'm finding out that you're not a cardiologist.

JENNY C. 14:56

Episode what is this six-, seventeen? It had to come out at some point.

JENN T. 15:01

Well, I love you know, I love a secret. So she couldn't obviously she couldn't sleep, she couldn't go to school. And she probably couldn't scream into the void which is honestly the worst part about it because sometimes you have to, and her family consulted several doctors but none could find the cause. So really quick, let's just take a brief second to talk about what causes hiccups, and in particular, long term hiccups like this three things, either nerve damage or irritation such as something touching your eardrum, like a hair. And these are just a couple examples. There's more examples of nerve damage I just popped up like picked a couple out like a hair touching your eardrum, which also sounds like a nightmare, or something like sore throat or laryngitis, which, that's so crazy because I do feel like I've had so many times and I've never hiccuped because of it. Some sort of central nervous system disorder like encephalitis, or meningitis, or multiple sclerosis, and so on and so forth. Or a metabolic disorder, or drugs like alcoholism. They very specifically said barbituates, which is strange. I'm like, What year was this written? I feel like I've heard the word barbituates in a day. like diabetes issues, kidney disease, it seems to kind of like anything could call it seems like a real mixed bag of anything can cause hiccups for a long period of time.

JENNY C. 16:21

Lots, lots of stuff. And how old was she at this time?

JENN T. 16:24

Fifteen

JENNY C. 16:25

Okay

JENN T. 16:26

And long term is described as more than two days and I'm like, I would argue long term's two minutes. I don't want that.

JENNY C. 16:32

Yeah, more than two hours like I hiccuped for several minutes before.

JENN T. 16:35

Oh, you have.

JENNY C. 16:37

Yeah, I only start to hiccup if I'm if I'm laughing too hard, or it happened more when I was younger. If I laughed too hard for too long. Then I started to hiccup and I think it's like a you're trying to catch up on your breath sort of thing. But it can be painful.

JENN T. 16:52

Yeah, but also kind of adorable now that you're describing it to me. So boy, I can't wait to make you laugh. We had a girl, when I went to high school, there was a girl. I won't name. You know, she shall remain nameless who had this like sneezing thing and one time in our English class and obviously kids are mean she kept sneezing and we just counted it out loud. That was shitty. We could have counted it silently. And she seized 40 times in a row. Forth times!

JENNY C. 17:22

Poor thing.

JENN T. 17:23

I know I'm a monster. Read every signature in my yearbook. It's not it's not great. It's like "Jenn it was so fun to make fun of others in class with you." Am I better? I hope so. Oh boy. This is a Debbie Downer, first day of my period. Here we go.

JENNY C. 17:39

Oh boy. Oh boy.

JENN T. 17:40

Oh by. Okay, so on February 16, 2007. a month and a half after the first hiccup, Jennifer Mee went on the Today Show to share her story. She received a deluge, my word, of suggestions from viewers. None of which worked.

JENNY C. 17:58

Of course not.

JENN T. 17:59

I wanted to find that but maybe I'm just very bad at Google but I couldn't find that. On March 1, 2007 she called the producers of the Today Show to tell them she woke up feeling a bit sick but suddenly her hiccups were gone.

JENNY C. 18:12

Wow, so how long did she have them?

JENN T. 18:15

Five weeks.

JENNY C. 18:16

Five weeks!

JENN T. 18:17

Yep. That's awful.

JENNY C. 18:18

That's too many weeks.

JENN T. 18:20

It's ur next podcast: Too Many Weeks!

JENNY C. 18:23

Too many weeks! And people are like "In regards to," we're like "It's too many! That's all you need to know."

JENN T. 18:28

You just have to listen to find out.

JENNY C. 18:30

Yeah

JENN T. 18:30

Um she attributed this miraculous cure to and I quote "my special drinking cup," there will be more on this later. a chiropractor, a hypnotist and an acupuncturist and don't tell the anti-vaxxers this but it's a real who's who of non FDA approved treatments.

JENNY C. 18:50

But it worked and she's not hiccupping. Okay, that's good.

JENN T. 18:54

Kind of, more on that as well.

JENNY C. 18:56

Okay

JENN T. 18:57

So, over two years later on November 16. 2009, the Mee family, and that's going to be kind of a bit of an Abbott and Costello situation. I'm sure when I keep saying things like Mee this and Mee that, it's gonna be a real knee slapper.

JENNY C. 19:10

Is it, ist it M-E-E?

JENN T. 19:12

Yeah

JENNY C. 19:13

Okay, double E.

JENN T. 19:14

But to the listener it sounds like this raging narcissist...

JENNY C. 19:17

You're like Jennifer me.

JENN T. 19:20

You're like "You?" And I'm like no...Mee.

JENNY C. 19:20

No Mee. Jennifer her.? No, Jennifer Mee.

JENN T. 19:28

Yeah Mee. Yeah, me. Yeah. Okay her, oh boy.

JENNY C. 19:32

No, it's me though.

JENN T. 19:34

Ohhh shit, ahhhhh. We're gonna need a real fucked up Venn diagram of or like a very. here comes the Charlie Day conspiracy meme. So, yes, on November 15, 2009, the Mee family filed a lawsuit against Hic-Cup. So it's H-I-C hyphen Cup. Very cool, listen, as someone who prides themselves on being able to name things in a very fun way.

JENNY C. 19:55

It's a great branding right there.

JENN T. 19:57

Yep, that was the special drinking cup. And I do feel like I have maybe seen the late night infomercial or As Seen On TV sort of commercial for this cup that's that claims to cure hiccups. I do feel like I've seen that.

JENNY C. 20:13

How is it designed? Is it like designed for different [UNINTELLIGIBLE]

JENN T. 20:16

It does something, I did look it up and I wish I'd written it down because I do have a bad memory so please don't quote me on this. But it does something to like you nervous symbol supposed to do something to your central nervous system in some way which feels like...

JENNY C. 20:27

A cup.

JENN T. 20:28

...something that tickles something. Is that good? Something that tickles something.

JENNY C. 20:31

But it's for drinking liquid?

JENN T. 20:33

It's, you I guess the way in which you drink it, it helps get rid of your hiccups. That's why it's called the Hic-Cup.

JENNY C. 20:40

Well again, not a scientist. I believe you.

JENN T. 20:43

And neither were they I bet. So, so they sued this company for unlawful use of Jennifer's image on their website. Now prior to this incident, Michelle I'm gonna say Ehlinger, E-H-L-I-N-G-E-R of Hic-Cup Ltd. had approached them. She's asking them if Jennifer would mention the cup during her Today Show appearance. I don't know if she held it up or had it or called it by its name, Armie Hammer is not great, but um, but that's the special drinking cup, which doesn't seem like an endorsement of any kind, but more must have been done. And for this she was paid I believe \$2500 which is not a lot for any sort of endorsement on a nationally televised show you basically got a national commercial for \$2500 which is not not what you should get. Beyond that appearance nothing was agreed upon, which is why the family was shocked to see screenshots of Jennifer from her TV show appearance on the website.

JENNY C. 21:41

JENN T. 21:41

Mm hmm. They sued for \$50,000 and Jenny when I tell you that I couldn't find if they won or lost they could not, I couldn't find it. I don't know I want to say no because I feel like that would have been somewhere but everything. every article that I read just said they sued and I'm like really? Come on.

JENNY C. 22:00

We'll assume they settled out of court.

JENN T. 22:04

Yes

JENNY C. 22:04

We can't know for sure. And everything was fine after that for Jennifer Mee. The End.

JENN T. 22:12

Yay, that was a great episode.

JENNY C. 22:14

Oh my gosh, I'm not sad at all.

JENN T. 22:16

I'm so sorry. I zigged when I said I was gonna zag.

JENNY C. 22:21

You're right. Continue.

JENN T. 22:23

Oh! Here comes the Crimeline of Events.

JENNY C. 22:28

Is it crimes against branding?

JENN T. 22:32

Oh I should have tossed that one under the Crimeline because that was a crime as well. In the summer of 2007 Jennifer ran away from home this is such a teenage thing, by the way. So in 20 in 2007 she I believe is 16 because she was born in 1991. I've had to do a lot of fast math for this episode, people are not given me ages. In the summer of 2007 she ran away from home for the first time after her parents took away her cell phone.

JENNY C. 23:00

Guess what Jennifer? I barely had a cell ph-, I was like did I have a cell phone? Yeah, I had a flip phone.

JENN T. 23:07

Yeah, that was the when the and that might have been also a time in your life when remember when like calls were only free after like 9pm and you paid for them during the day?

JENNY C. 23:16

Yes, yes, we are aging ourselves. We're like a microgeneration of people who had cell phones when they were young but had to pay 25 cents per text

JENN T. 23:28

And you had to do that thing where you had to like the letters were if you wanted to get to be you had to hit like a be on like ABC 123 like just to get you remember that how to type out letters.

JENNY C. 23:39

We're being really relatable but I've looked at our stats and not many young people listen to us so it's okay

JENN T. 23:46

No, we just need to get a hella young guest and hella is a very modern piece of slang.

JENNY C. 23:51

So modern! I heard, someone said on Twitter that was like someone saying you rule is like retro or like mom like. Um.

JENN T. 24:04

Is it? I don't even know if I've ever said it.

JENNY C. 24:05

It fucking rules and I say that a lot. So guess what I still rule, continue your story.

JENN T. 24:14

Big Mom energy. So here's why they took away her cell phone though evidently all the attention she garnered from being hiccup girl. She got a lot of, you know, this was the age of still I don't know 2007 I'm trying to remember what the Internet was doing in 2007. I have zero recollection of the Internet in 2007 but she was getting a lot of messages from people. And apparently she had been exchanging some illicit messages with strangers who all wanted to know the hiccup girl. So you know, so she ran away for a one day and who among us. I certainly did that. Oh, I'm out of here up the street. So later in 2008 she started hiccuping again at school and was asked to leave. That same year she was placed in a psychiatric hospital by her mother who said she was functioning and I quote on the level of a 12 or 13 year old so by then she was 17. She never went back to school. Two years later, she ran away again, but this time she didn't come home. According to Major Mike and I am not gonna say this last name correctly. Kovichev, this is bad, you'll see it in the transcript, of the St. Petersburg Police dDepartment shehad a quote unquote transient lifestyle. His run ins with Jennifer were frequent, at least a dozen between 2008 and 2009, which is a lot. But she was never...

I was gonna say who hasn't sold drugs. I have not sold drugs.

JENN T. 25:57

But you know what? I? I don't know, I never, meh...

JENNY C. 26:04

She's trying to survive.

JENN T. 26:05

Yes, so perhaps the best way to describe Jennifer's life at this time, in her own words was via her MySpace bio. And that's exactly what the Internet was doing in 2007/2008. And this is, and I quote: "My name is Jennifer. I am almost 19 but don't let the age fool you." you. Oh boy. "The struggles I've been through has made me grown up so much. I'm always having fun, chillin'." This is a very emotional that was a roller coaster. I have a lot of struggles but also please don't worry I'm having a lot of fun please.

JENNY C. 26:43

I'm chilling I'm a cool girl. Don't worry.

JENN T. 26:47

Listen, just because I'm freaking out right now it doesn't mean I'm still not fun to hang out with.

JENNY C. 26:50

I like to party. Don't worry.

JENN T. 26:52

Yes and she did. So after the media attention from hiccup gate died down she turned to selling drugs. meeting people online and possibly leading up to a quote unquote 'drug Empire" as a self described quote unquote, "female version of a hustla."

JENNY C. 27:10

Okay, sure, so very MySpace.

JENN T. 27:14

Very MySpacre. Remember the drama, here we go this is gonna be real who's who of what life used to be like. Do you ever the drama of moving people around in your top 8?

JENNY C. 27:25

Your top 8, yeah.

JENN T. 27:26

...like what that caused people? God I still wish we had that sort of vicious way of because that was very viscious in its own little little way. So okay, here we go. This is now really getting into I mean, that was like pre crimeline. But here's the crimeline ov events. In October of 2010, Jennifer was sharing an apartment with her boyfriend aspiring rapper, just want to let that float in the air, Lamont Newton who was 22 and his best friend Laron Rayford, who was 20. Jennifer was receiving some, she was getting Social Security disability benefits for the hiccup thing. So she had some money from that obviously the drug Empire was seemed to be taking off.

JENNY C. 28:09

That makes sense because she couldn't, she couldn't really really work or it was pretty debilitating.

JENN T. 28:15

Yeah, yeah so but you know, they still they still needed money because they were a bunch of you know, 20 somethings living in a weird apartment.

JENNY C. 28:26

Sorry I'm making faces there's a fire truck outside.

JENN T. 28:30

Is it coming into your building?

JENNY C. 28:31

I don't think so.

JENN T. 28:33

Wow, listen you have to be part of our art.

JENNY C. 28:39

This is our time they're just like kind of loud.

JENN T. 28:42

I can't hear them.

JENNY C. 28:43

You can't hear them?

JENN T. 28:44

No ma'am.

JENNY C. 28:45

Engine number nine

JENN T. 28:46

Oh, isn't that a from like a song "Engine engine number nine. going down the...."

JENNY C. 28:52

They're getting, they're getting back in the fire truck so maybe...

JENN T. 28:56

False alarm! JK, JK guys just hanging out.

JENNY C. 28:59

Yeah, they're leaving. Anyway that was your fire department of greater Washington, DC update for the week. Please continue. I'm leaving that in.

JENN T. 29:07

Leave it. Okay, so on October 23, 2010 the three of them went out for the night after Jennifer met 22 year-old Walmart employee, no idea why that is significant but it's mentioned in numerous places, Shuh-non Griffin online.

JENNY C. 29:24

They were proud of their work.

JENN T. 29:26

Yeah, yeah they wanted, they wanted Walmart to kick some money their way for this.

JENNY C. 29:31

Shu-non not Shannon?

JENN T. 29:32

It is Shuh-non and the only reason why I know this is because I when I listened to and I'm going to assume this is right when I listened to briefly the I also listened to and maybe I left this one out and I do apologize another source was the "Criminal Broads" podcast

JENNY C. 29:47

Oh you did say that.

JENN T. 29:47

Yeah okay. The host said Shuh-non, thank God.

JENNY C. 29:50

Alright

JENN T. 29:51

Because because Shuh-non is is a man, not that matters, there are men named Shannon but in this instance, she said Shuh-non, the host so I will assume it is Shuh-non.

JENNY C. 29:58

I kind of like it. I kind of like it. Why not?

JENN T. 30:01

It's lovely.

JENNY C. 30:01

And it's like pronouncing both N's giving them their own place.

JENN T. 30:07

Juh-non-uh-fer. Nope, Juh-non...

JENNY C. 30:08

Jenn, Jenn, Jen-Nifer

JENN T. 30:11

Oh boy.

JENNY C. 30:11

No I don't like that Shuh-non though it works.

JENN T. 30:14

Yeah, Shuh-non works better. So they met Shuh-non, or Jennifer met Shuh-non online and the plan was to trick him into coming to an abandoned house where Rayford who was not the boyfriend again, Newton, and Newton would rob him. This is a classic. This is a classic ploy.

JENNY C. 30:32

It's gonna go great.

JENN T. 30:34

Now, Jennifer, I have a lot to say about this and I, which says a lot about me I'm sure. Jennifer was on a combination of ecstasy, marijuana and cocaine. Now those three, that's a crazy, the ecstasy and cocaine I can see. And I'm not ashamed to admit I've done those things together before.

JENNY C. 30:57

Yeah, that's like very, like pleasure seeking.

JENN T. 30:59

Yeah I get that. But I think that if you're doing ecstasy and cocaine, marijuana is not even gonna make a dent unless you're trying to come down from the cocaine. It's the ecstasy that's very strange, because like, like marijuana and cocaine kind of go hand in hand, I see how that could be a thing. And then suddenly, you're throwing ecstasy in there. And that's just where are we going with that one?

JENNY C. 31:20

Here's the thing if you're like smoking weed all day...

JENN T. 31:23

Oh okay.

JENNY C. 31:24

...which I'm not gonna put it past, Jennifer. Maybe she's just keeping a buzz enjoying her life.

JENN T. 31:30

Okay

JENNY C. 31:31

And then someone's like, oh, by the way, I have this ecstasy, and you're like, Oh, that sounds great. I've already smoked some weed, but that's fine. And then you take the ecstasy, and someone else is like, oh, by the way, I have some cocaine. And you're like, yes, cocaine, please. That sounds great. And then all of a sudden, you're on all three of those things.

JENN T. 31:47

Yes I can see that. Okay, I can see that happening. I can also see her being like, I am too high from this ecstasy, I need to balance it out a little bit, which is maybe where cocaine comes in. Either way, no wonder everybody's broke. This is a very expensive evening, or can be rather at least with the with the cocaine unless it's not great. Anyway so this is all of these things at once inside of her body is why she claimed to not remember how Shuh-non Griffin ended up at the abandoned house though I'm sure it doesn't matter how he got there.

JENNY C. 32:15

I don't think, I don't most of those drugs don't work that way, though. So I've never taken all three of them at once, or actually any of them separately, but.

JENN T. 32:25

Yeah, I think that ecstasy is the one you're most likely not to remember something.

JENNY C. 32:29

Okay so that's fair. So I don't know. That's plausible, but not probable. I'm gonna say?

JENN T. 32:35

Yeah it just sounds like a lie she told to, you know.

JENNY C. 32:37

Yeah

JENN T. 32:38

So, so, so he shows up, and there's a struggle of some kind. I don't even I mean, but some other things happen and that will be explained in a second, but during the struggle, they they have a gun, Newton and Rayford. Evidently Jennifer's not there. During the struggle for the gun between Griffin, Newton and Rayford, Shuh-non was shot four times in the chest, and was robbed of less than \$50.

JENNY C. 33:06

Ugh

JENN T. 33:07

So all of that, not that it would ever be worth it, but less than \$50.

JENNY C. 33:13

It makes it that much more senseless.

JENN T. 33:17

Yep

JENNY C. 33:18

These are always senseless a crime like that, because you're taking someone's life for money, but for \$50 it's, it's horrific.

JENN T. 33:28

And I do want to say that and I'm sure this would mean very little to his family, but this just tells me and this is an assumption I'm making and cannot confirm that he tried.

JENNY C. 33:38

He tried tried to fight back.

JENN T. 33:41

But like also at the end of the day, please always just give somebody your money and like just give them your money. This is not me victim blaming at all, but just give them your fucking money.

JENNY C. 33:50

I'm sure he tried to fight back just because he was afraid of getting hurt.

JENN T. 33:54

Yeah, absolutely.

JENNY C. 33:56

And they had a gun. So he was trying to probably get out of there.

JENN T. 34:00

And if you are someone with \$50 is a lot of money and someone's trying to take your \$50 and that's maybe the difference between a meal or whatever, you're probably going to fight for it. Honestly. So again, Jennifer Mee was not there, evidently, didn't pull the trigger wasn't there. Now, wait for this surprise, which I think you're gonna, I'm gonna use the word like though it seems not appropriate. According to a fourth roommate, Jennifer Charron, or Sha-rone, Double Jenns. There's another roommate named Jennifer who also lives with them who until this moment was not mentioned.

JENNY C. 34:38

Okay. She got like keeping it low key.

JENN T. 34:41

Yep, two Jennifers who was not with the other three roommates. According to her that night they were all supposed to go see "Paranormal Activity." Great movie.

JENNY C. 34:52

Okay

JENN T. 34:53

And this reminds me of the fact that the Menendez brothers, one of the alibis that they tried to use was that they were going to the movies and they did and this is a cra-, this is something that i i i think about honestly too much. They tried to go see "Batman," another great movie, but it was sold out so instead I shit you not they saw the new Bond movie "License to Kill." That is a true story. That is a movie that the Menendez brothers saw on the night they murdered their parents. I wish that was a joke anyway so according to the mysterious second Jennifer, her name is spelled C-H-A-R-R-O-N. How do you think I said Sha-rone? Sharon? Sure.

JENNY C. 35:33

I'm gonna say Sha-rone.

JENN T. 35:35

According to Jennifer Sha-rone, these were the plans they had the night of the murder. So at some point in the evening, Jennifer Mee enters the apartment looking distraught while claiming that she heard gunshots so I guess where this abandoned house was was close enough to their apartment that she could make these claims that she heard gunshots and...

JENNY C. 35:54

And Jennifer Sha-rone meanwhile was like "Guys I waited for you at the movie theater. I already had my popcorn. Where were you?" Jennifer's like "I heard gunshots. I'm on drugs. What's a movie? I don't know."

JENN T. 36:08

This sounds like it could be some *looks at the camera* paranormal activity.

JENNY C. 36:13

Boom

JENN T. 36:14

So then, and I this is from the weird book that I got the person who wrote the book and again, I also looked at a lot of these newspaper articles because I was like this person writes like well they've never written before. She jumps around a lot, the author of the book. So then for some reason, Rayford comes home, and claims that Newton was shot. But then moments later, Newton is again Jennifer's boyfriend, moments later Newton comes in unharmed and Newtons just says Shuh-non Griffin had been shot. And I guess maybe what you're supposed to glean from this is Jennifer Charron was aware of the fact that maybe they were going out to meet a guy but maybe she knew or didn't know why but that he was just like "Oh the gunshots you heard, that was Shuh-non getting shot."

JENNY C. 36:57

But they didn't admit that they shot him? They're like "He got shot," not "We shot him." But where was Jennifer when he was shot?

JENN T. 37:05

I think she was at home.

JENNY C. 37:07

She was just outside or...

JENN T. 37:09

They claim she wasn't there. It's been, it's definitely a fact according to all the various coverage that she did not pull the trigger.

JENNY C. 37:16

She like lured him there basically.

JENN T. 37:19

Yeah

JENNY C. 37:20

Got it.

JENN T. 37:20

But she set it up, so not sure why this comedy of errors going on. But within hours of the crime Jennifer Mee, Lamont Newton and I think it's La-rone Rayford were all arrested. Presumably because of this overwhelming evidence. Number one, a condom wrapper was found at the crime scene with Rayford's DNA on it. And number two, Griffin's wallet was found at the Mee/Sharone/NewtonRayford apartment with Jennifer's fingerprints on his license. Not great.

JENNY C. 37:51

Wait so they're having sex at the abandoned house after they murdered someone?

JENN T. 37:57

Well what's interesting, and I didn't include this, but I did read it several times is the defense attorney claimed that that didn't prove anything because that could have been just left there at any time, you know. And also they pointed out and I didn't include this because it just didn't seem relevant but Shuh-non Griffin's pants were at his ankles when his body was found so and I didn't see anything about that DNA evidence. Like maybe they swabbed Jennifer and found hi-, none of that seemed to come up but for whatever reason, it was mentioned that his pants were at his ankles, so I don't...

JENNY C. 38:31

Maybe they were trying to stage it to look like something else that happened.

JENN T. 38:35

Well, Jenny, very astute here we go. During her initial interview with the police Jennifer Mee said a love triangle between her. Rayford and Griffin was going on so not her boyfriend.

JENNY C. 38:48

The roommate.

JENN T. 38:49

Yeah, and her boyfriend Lamont Newton was unaware of the affair but it was, he didn't get angry. Rayford got jealous and because he didn't want to share Mee with Griffin, not me. I don't want to see, I don't want to date any of these people. Jennifer Mee with Griffin. But then of course Mee later changed her story and all three of them admitted to their involvement and we're charged with first degree murder which carries the death penalty in the state of Florida. And despite the fact that Jennifer me did not pull the trigger under Florida law her involvement with a robbery turned homicide is what made her eligible for first degree murder charge. So that's and that is a okay, and that law fuckin sucks. And it sucks so hard that even suck face Piers Morgan was mad about it and he sucks.

JENNY C. 39:38

He's real bad, real bad.

JENN T. 39:40

Yes, Jennifer Mee was interviewed by Morgan in July of 2017 for his show "Killer Women," but I didn't watch that because he sucks.

JENNY C. 39:47

Don't want to hear him talk but he made maybe one correct opinion about a lobbying too harsh

JENN T. 39:53

The law sucks. That's about it. That's what we can all agree on. So the trial happened almost three years later. Almost exactly three years later in September of 2013. Jennifer Mee pled not quilty. Her attorney John Treveno claimed she was the victim based on her past which is interesting. There's like, you know, this there's a lot of defenses revolving around abuse that Alan Dershowitz tries to dispute the book he once wrote. And, you know, so things like battered women's syndrome and I guess here John Treveno is trying to claim that based on everything that happened to her that this is like a reason why she would be involved in something like this. He also stated that she suffered from schizophrenia and Tourette syndrome. This is because, this will be relevant in one second, he further went on to say that Tourette's was what probably caused the hiccups and Tourette's is usually treated with Thorazine, which is an insanely crazy drug. Thorazine is insane and is sometimes used to treat psychotic disorders. So her attorney posits that the Thorazine effectively hid her schizophrenia, which is how they missed the diagnosis for so many years. And what is, what and why this has all happened. This is such a song and dance. This caused Mee to have several me again several quote unquote, errors and errors in judgment like this phone call she made to her mother from jail and Jenny, I have a video. It's a little over two minutes long if we do want to hear it. I hope you do.

JENNY C. 41:27

It's happening.

He sounds very calm.

So the part that's, it's really heartbreaking, but the part...first of all thoughts on that call?

JENNY C. 43:20

Well do people in jail not understand that they're being recorded at all times when they're on the phone?

JENN T. 43:31

Um, well, Jennifer is actually and like we're actually almost done, but in like one at some point during her trial the judge orders a psychiatric evaluation and the only thing just to see if she's competent, and based on everything that her lawyer was trying to get to make happen. And she was not only was she found competent, but they found that the only thing wrong with her was that she was below average, had a below average intelligence. So I just think that she was just making, and you know, this is not a person who probably sat around watching as many horrendous documentaries and courtroom dramas and etc, etc. as I don't know, say I have. So it

is possible that she just didn't know or didn't think. But I think she's just scared and obviously very upset.

JENNY C. 44:21

Yeah, yeah and as soon as she gets on the phone with her mom, then she starts to kind of break down a bit.

JENN T. 44:28

Yeah, because I think the other person's her stepfather I assume.

JENNY C. 44:31

Yeah, that is wild to call and tell someone I'm in jail and it's for first degree murder.

JENN T. 44:38

But also everyone seems remarkably calm. I have had to phone my mother from a jail. This is a real bad, I'm not admitting a lot of great things about me in this episode, but that's okay, own your past, and my mother's reaction was not "What? What was that?" Like again this woman says "Who'd you kill? What? My mother would be flipping out, I think.

JENNY C. 45:06

I mean I think her mom's probably in disbelief.

JENN T. 45:09

Maybe my mom seemed pretty able to freak out over my ridiculous like, stupid arrests that I've had to like it like...

JENNY C. 45:18

Also well, and also Jennifer's been arrested before. This might not be the first time she's called. We don't know for sure if she would have called her mom at other times, but this is the most serious but she, Jennifer seems upset but also, I don't know that she senses the gravity of this situation.

JENN T. 45:38

Yeah because at this point, she was just charged by the police. So she had...

JENNY C. 45:43

Yeah

JENN T. 45:43

...she's not gone to court yet.

JENNY C. 45:45

And she's kind of figuring out what her story is gonna be.

JENN T. 45:49

Yeah and the thing that was damning that later in court that they found so damning was when she said "I set the whole thing up."

JENNY C. 45:56

I set the whole thing up.

JENN T. 45:57

Which is what they use to get her for this, using is insane Florida law.

JENNY C. 46:04

Okay, so then what happens that so that was at the trial and then played that and then what happened?

JENN T. 46:08

It lasted five days and on Friday, September 20 after deliberating for four hours, not a long time, the jury declared her guilty and sentenced Jennifer to life without parole as she openly sobbed in the courtroom, which is what I would do too. She tried to appeal the decision but was denied and she is still sitting in Lowell Correctional Institution and I've never said this, is it Okala? Ocala, Florida.

JENNY C. 46:34

No clue.

JENN T. 46:36

We're doing great this time. I looked up her inmate information to see if I could find anything else and Jenny would you like to guess what her middle name is?

JENNY C. 46:43

Is it Ann?

JENN T. 46:44

it is Ann.

JENNY C. 46:45

It's Ann

JENN T. 46:46

It is Ann.

JENNY C. 46:47

Oh Jennifer Ann.

JENN T. 46:49

I know, what did that look at that her initials are JAM. She could have had a way...

JENNY C. 46:53

Yeah

JENN T. 46:54

...like not her and this is what the Sad Jennifer being of course, she was you know, this law was a piece of shit law and her childhood was totally fuckin' fucked up and honestly, unfortunate I can't I can't classify her as a bad Jennifer. Can you? Certainly a Misguided Jennifer.

JENNY C. 47:13

It's very complicated because a person is dead. Some, you know a person is dead who does not deserve to be dead.

JENN T. 47:21

I think that's a Bad Lamont and a Bad Laron.

JENNY C. 47:24

Yeah and she yeah, I think she probably just didn't think through the consequences of what that could be. You know, you bring a loaded gun somewhere, you have to understand that it might get fired.

JENN T. 47:38

Yeah, like, honestly, this is not a now I'm about to tell you just don't load your guns is what I was gonna say. But like truly in a scenario like that? I don't know. That was this is not an please God I'm not this is not advice I'm giving people but it is a little suspicious and strange that the gun was... Yeah ...uou know like, why?

JENNY C. 47:55

Yeah I mean, she she didn't intend to murder. She has to be culpable for, you know, playing a part in this, but I don't think life in prison is the answer there.

JENN T. 48:08

And also the definition of being involved in a robbery is, and I'm sure this is one of the many issues that are that are brought up about this law. But like, what is involved mean, setting it up? Yeah, you're involved but the actual robbery itself, then you're not involved in the robbery you're involved in the planning of it. So isn't that a different definition? Bah, bah, bah, bah. I'm sure this a conversation that's had at length with professionals.

JENNY C. 48:35

Yeah, and I don't think anyone is saying like "Oh she's completely innocent of any involvement," because she admittedly was involved in this situation. But it obviously went to a place she couldn't have imagined so what happened to the guys did they...

JENN T. 48:52

I actually I didn't read they both got life in prison without parole as well. But again, just kept that focus on the Jennifer. So what's really kind of disappointing, not disappointing what's the kind of like, I really kind of thought, well, the hiccup part will probably be a little lighthearted and then the other part will be and that was not equally obviously as devastating but still devastating because she was harassed at school. People made jokes you know, we have, you know, sexual innuendos about ways in which she could of course, stop the hiccups from happening, you know, kids are monsters. And you know, it just wasn't it was awful top to bottom.

JENNY C. 49:31

Yeah she never she didn't have any support. And then yeah, and then of course, was drawn to the wrong people. Yeah, I don't I don't think she got her fair, a fair shot.

JENN T. 49:50

No and I can't believe one of the only saviors for her cause is Pierce fucking Morgan, who is a woman hater. at that. very least a hater of women, that fucking guy. So I can't imagine like, you know, the fact that he has sympathy for anyone whatsoever is shocking to me.

JENNY C. 50:09

Yeah, yeah, that is shocking actually. She's also white so I'm sure that helps.

JENN T. 50:16

Yeah and I believe when I looked at, I didn't look at every photo of all the women that he did the season called "Killer Women," and she's like episode 3. Also, you can find an episode of maybe not "Snapped," but I think it is "Snapped," it's on Peacock. I actually didn't get to watch it but I think the gentleman who wrote the 496 page book is featured prominently in it. How could he not be? So I might watch that as well because maybe it answers some other questions or gives you some more information. So I would urge anyone who wants more of the story to perhaps watch that.

JENNY C. 50:47

Well, yeah, thanks for the bummer.

JENN T. 50:49

Yeah, yeah.

It was sad but there was also some levity in that story. There was some hijinx. This one is just like fucking bummer. I actually have one picked out or the next one.

I should have, I wish I but you just don't know until you get into it and then it's too late. I'm like, I'm already here. I kick it out.

JENNY C. 51:26

Yeah and this one on paper. You're like, Whoa, hiccup girl turn murderer. And then you're like "Oh it's way more complicated and depressing."

JENN T. 51:33

Yeah I remember when we were thinking of some Bad Jennifers. That's when we're both like, "Whoa this will be pretty crazy." Nope! So... Wow, well, you're gonna have a real fun time naming this one. Hey can't wait for you to pull out some hilarious Instagram slides from this adventure. Yay!

JENNY C. 51:43

Well thanks for sticking with us, those of view and this was a shorter episode too. Maybe that's for the best.

JENN T. 52:03

Yeah, it really is. Next week, I don't know what we're doing but I'm gonna just pre promise something very light hearted.
