Reminder Notice

Notice Of Conditional Acceptance Upon Validation Of Claim

Opportunity To Cure

please read the following Notice thoroughly and carefully before responding; it is a Notice, a lawful instrument that requires your urgent attention; it informs you; it means what it says; this 'Notice of Conditional Acceptance' may be used 'as created', as evidence in my defence, in any circumstance of my choosing;

this Notice is also addressed to your heirs, representatives, permitted successors and assigns where applicable, should any of these take over from you and assume control over your people;

action point numbers continue on from our Notice No2 dated 25.03.22;

as a reminder, Notices were sent to you on:

- 10th March 2022 reference number **AA123456789GB**, received by you on 14th March 2022 (**track and trace confirmation of delivery**), and
- 25th March 2022 reference number **AA123456789GB**, received by you on 28th March 2022 (**Appendix B – track and trace confirmation of special delivery**),
- 25th March 2022 reference number **WW123456789GB**, received by you on 28th March 2022 (**Appendix B – track and trace confirmation of recorded delivery**),

this confirms that UKPC Ltd's business address and UKPC Ltd's PO Box1608 are the same;

we also refer to your letter date 04 April 2022, the contents of which have been carefully noted and we will comment on them in due course;

it is noted that as of the date of this reminder Notice, no reply has been received to either of the two previous Notices dated 10th March 2022 and 25th March 2022;

the two Notices listed above remain in full force and effect, pending receipt of the documentation and action point answers we require and have requested you provide;

you have so far failed to provide the true original documents and lawful first hand evidence that requires a discharge of any lawful owing debt due to UK Parking Control Ltd and to Rupert John Williams;

take notice Rupert John Williams that you have twice been requested and required to provide proof of a valid claim; which you have ignored, knowingly, willingly and wilfully with intent of your own free will and omission;

we are perplexed at your total disregard for the laws of our land and would urge you to consider seriously this lawful request and the implications of your silence in this matter;

this reminder extends the deadline of our second lawful Notice by a further 7 days;

therefore unless we receive all of the original true documentation requested within a further seven (7) more days, from the date of receipt of this reminder notice we will proceed with our own litigation against these claims you seem unable to either consider or simply do not have the documents to show a valid claim we have demanded of you on previous occasions;

to remind you yet again, we state for the record this Notice is not a refusal to pay, it is a "conditional acceptance" to settle your alleged debt upon proof that you and your company have a valid claim and the only requirements we have of you and your company at this time is you furnish us with concrete and valid proof of your claim;

now to address your letter of 04 April 2022 which again is fraudulent in nature as detailed in our Notice of 25th March 2022; an unsigned document, with no visible representation or name to it, is a fraudulent document ab initio, from the outset; it cannot be treated as a valid legal document; it is a if it doesn't exist; it is therefore rejected and 'returned to sender';

there can be no 'final decision' because there has been no 'appeal' made; your last correspondence relating to your alleged 'decision' was and is rejected;

you state that "The parking charge has been legitimately issued and at all times UKPC has adhered to the British Parking Association Code of Practice;

you are correct in stating that UK Parking Control Ltd is a member of the British Parking Association (BPA) and must therefore abide by the Association's rules;

action point 27 please prove that we are a member of the British Parking Association, because we don't recall ever joining such an association; without this proof, your comments and the rules of the BPA are therefore irrelevant and do not apply to us;

and while we are on this subject, **action point 28** please prove that we are bona fide members of your limited company, that we are your 'property' and that you can 'administer' us without right;

again you erroneously make reference to "the provision of an appeals service" and "POPLA"; this so-called service is not something we are obliged to engage with in law; it is merely something you must provide under the rules of your membership of the British Parking Association; it doesn't apply to us as stated above;

your letter states that "any attempt you may wish to make against UKPC in reasonably dealing with this parking charge is categorically rejected"; this wording doesn't make sense; we have not 'attempted' anything; you were given ample notice of our fee schedule in our notice of 10th March 2022; that our time is not free and that our time would be charged accordingly if you continued with your vexatious and frivolous Parking Charge Notice without your required validation of claim;

you have indeed continued as evidenced by your letter dated 04 April, so you have generated yet another invoice to be added to our first commercial invoice; these costs will be added together for a claim should this matter go before a court;

it is noted on the record that you have not returned our valid commercial invoice and you have therefore accepted it; it is now overdue;

and yet again, there is no name of any human taking responsibility for your latest letter; fraud as detailed in our Notice No2 which remains in full force and effect;

also your letter is addressed to MISS FIRSTNAME MIDDLENAME LASTNAME, in direct contravention of our instruction in our last notice to only address me by my compound fact name of :Firstname-Middlename:Lastname, as commonly known; no other form of address is acceptable;

please cease and desist with your venal abuse of my given name; you are hereby put on notice that we reserve the right to cease responding to any of your correspondence addressed incorrectly;

for clarity, we enclose a copy of our Notice dated 25.03.22 and we repeat our Validation of Claim in summary form on the next page;

Validation of Claim Summary

we would be willing to settle any financial obligation we might lawfully owe, on the alleged debt, on the condition that we receive the following documentation from you; we require ALL documentation to be presented to us in the name of :Firstname-Middlename:Lastname in **substance** and with **full disclosure**;

- 1) validation of the alleged debt owed with **full** accounting; this includes but is not limited to a full accounting of the verified and quantified loss to the land owner;
- 2) a copy of the relevant and lawful Terms and Conditions;
- 3) Deed of Novation: my wet signature on any trilateral agreement between your company, the landowner and myself;
- 4) verification of your claim against me such as a legally sworn personal affidavit;
- 5) a full and valid VAT invoice or true bill, compliant with the Value Added Tax Regulations 1995, Part 3, even if VAT exempt;
- 6) a true and certified copy (Not photocopy) of the Deed of Assignment (Not Notice of Assignment);
- 7) the signed contract between myself and your company/organisation;
- 8) all men and women who sign for and on behalf of the company must be fully named, identified and properly authorised as an officer of the company;
- 9) a full and substantive rebuttal of ALL points marked **action point(s)** in the body of this letter;
- 10)state exactly who you are; your full name, job title, public ID details and your full address;
- 11)state who the claimant is; let him or her step forward and properly identify themselves;
- 12)state who you are making your claim against; unless you are seeking a living man or woman for an alleged crime against a potential or actual injured party, there is no valid claim; remember that as a man or woman in our living private capacity, we are not a dead legal fiction NAME, nor should we answer to such a thing;
- 13)state who the injured party is; there can be no valid claim against us as a living man or woman unless another living man or woman has been injured by us and is able to come forward to verify their claim against us under oath, accepting their full commercial liability, upon penalty of perjury; who are they?; where are they?;
- 14)i don't accept your offer to contract, and i do not consent to these proceedings;
- 15)i declare my living standing: “for and on the record, i:Firstname-Middlename:Lastname am a living woman, and that is my only capacity in this matter; i reserve all my rights waiving none, including my right to remain silent”;
- 16) “for and on the record, i:Firstname-Middlename:Lastname a living woman, hereby serve Notice for you to now provide me with 'articulable probable cause' in the documents that we have requested that i am a party to a crime against a potential or actual living victim; that verifiable and quantifiable loss has occurred to the landowner or your company; that you agree in fact you do not have standing in this matter, and that you are liable in your private capacity, accepting your full commercial liability, upon penalty of perjury, for any false claims against me, and the resulting damages, whatsoever”;

we hereby give you a further seven (7) days to reply to all previous Notices from Monday 11th April 2022, the verified date of receipt of this notice via Royal Mail Special Delivery Service;

your failure to provide the aforementioned documentation within a total of twenty one (21) days, from the date of our second Notice to validate your claim of debt, will constitute your agreement to the following terms –

- 1) the debt did not exist in the first instance and/or it has already been paid in full;
- 2) that you will be held liable for any and all damages to me incurred by any further actions;
- 3) remove any negative remarks made to a credit reference agency forthwith; since case law clearly states "Unenforceable debt cannot be placed on a credit file." (Court of Appeal Grace Vs Blackhorse); doing so will potentially incur claims for damages under the DPA;
- 4) you will no longer pursue this matter and that you have withdrawn all demands and claims against us;
- 5) since the evidence suggests you are not in possession of the required documents to substantiate any claim, you will cease and desist and withdraw any and all claims from this point onwards;
- 6) by accepting admission you're not in possession of the original agreement you will disclose why this came to be;
- 7) disclose who does have possession of the original agreements and documents;
- 8) our fee schedule for further infringements of our terms and conditions;

as per our last Notice dated 10th March 2022, i now enclose a new invoice with my fees owing to this date; further fees will accrue as per my schedule, unless you withdraw all demands you are claiming against me;

we wish to deal with this matter in writing and we do not give your organisation permission to contact us by telephone, or by any other means; should you do so, we must warn you that the calls could constitute 'harassment' and we may take action under Section 1 of the Protection from Harassment Act 1997 and the Administration of Justice Act 1970 S.40, which makes it a Criminal Offence for a creditor or a creditor's agent to make demands (for money), which are aimed at causing 'alarm, distress or humiliation', because of their frequency or manner;

do you wish to proceed any further if you are currently aware of 'no valid claim'?:

if so, you knowingly, willingly, wilfully with intent of your own free will and omission by your own hands commit to your actions;

our time is not free; any further correspondence and actions will be charged at our normal administrative rate as per **Exhibit A** and added to an invoice should you wish to continue to pursue this matter without any lawful validation of claim;

to make our position clear on the schedule fee below we gave you the first Notice for free; rest assured any further communication will be charged at the rates set out in **Exhibit A** should you continue to make any further claims against us without the requested documentation and proof of validation of claim;

all accrued fees will be cancelled in the event that you withdraw all charges without liability on either side;

any threats of court action will be deemed as such - 'threats' and 'harassment' - placing us under duress and will be included in any and all future claims should you not provide the lawful documentation of to support your claim; while we are in negotiation, and NOT in dispute, nor under 'appeal', all threats of court under statute law are meaningless and therefore constitute harassment, duress and possible fraud;

so please withdraw your charges and threats which are totally without foundation because you have failed to validate your claim;

Rupert, you have been put on Notice of Personal Liability and duly warned;

i am in perfect health and of sound mind;

i reserve the right to produce all paperwork in a court of law or in court proceedings as required by any court, including pre-action protocols for full disclosure;

i remain honourable, standing in truth, and wish to honourably forgive and resolve trespass without conflict;

i declare that all herein be true under penalty of perjury;

sincerely, without admission of liability or in any way intended to deceive whatsoever, without vexation, frivolity or ill will;

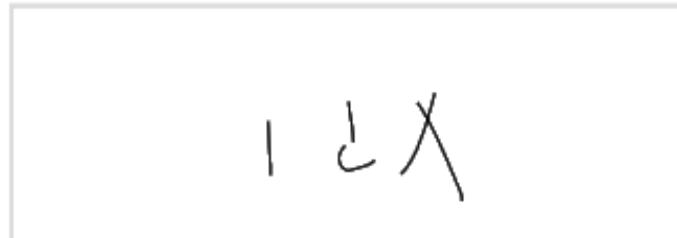

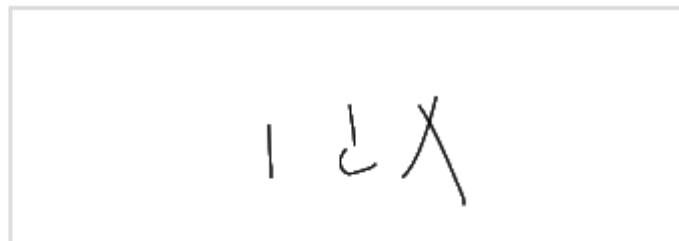
