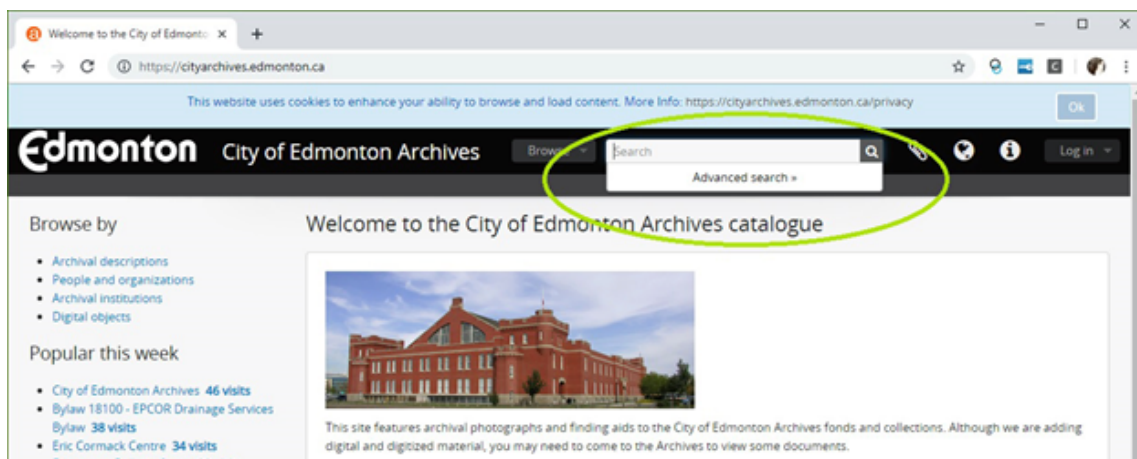

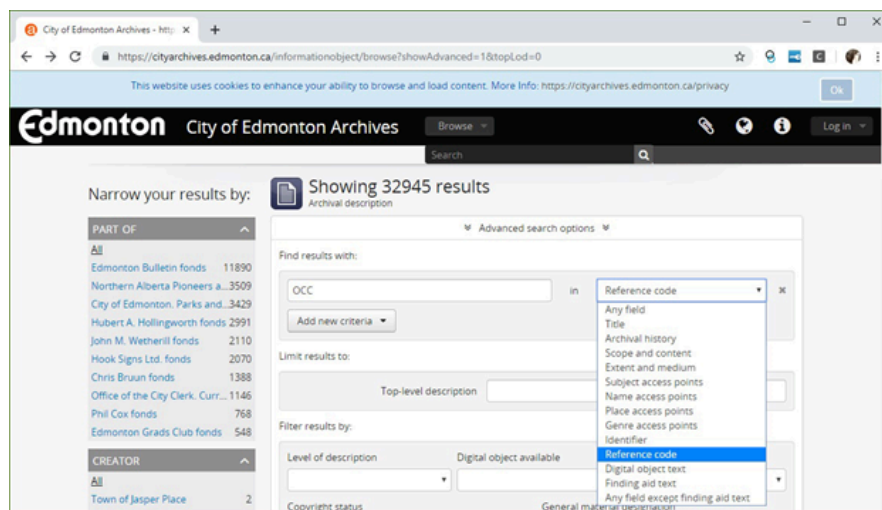
Current Bylaws

Many current bylaws are scanned and available. To search for a current bylaw:

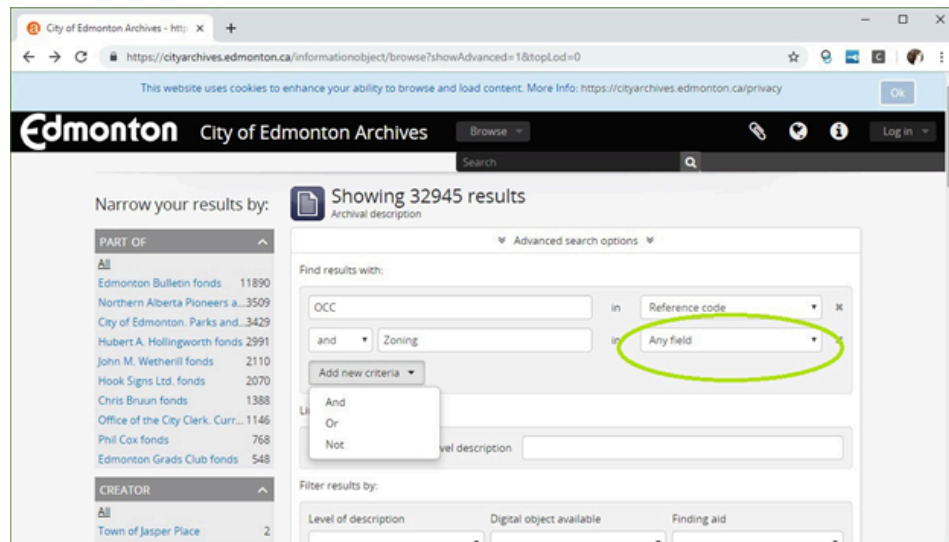
1. Click in the search box in the black toolbar
2. Select Advanced Search




3. Add OCC in the search box
4. Select **Reference Code** in the drop down



5. Add other keywords (zoning, Strathcona, taxi, etc.) by clicking on **Add new criteria** and selecting **And**
6. Leave drop down as **Any field**
7. Hit enter and scroll down to results



8. Click on the bylaw you would like to view.
9. To download the PDF:
 - Click on the picture of the first page. The document will open in another tab.
 - Click the download button  in the top right hand corner of your internet browser and save to your computer.

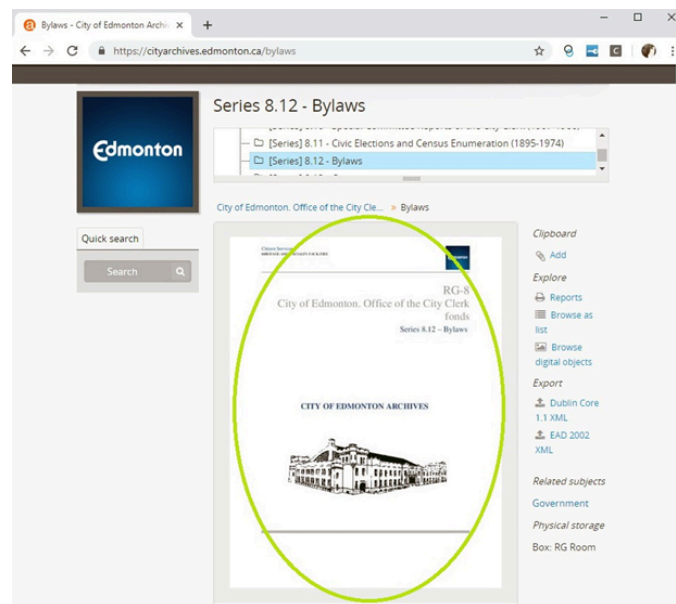
