1. Information We Collect

We may collect the following information during the beta testing period:

- Your email address (submitted via Google Form for TestFlight access)
 - App usage data provided by Apple through TestFlight (e.g., crashes, performance metrics)
 - Optional feedback you submit (e.g., surveys, reflections, testimonials)
 - App interaction data (e.g., verses viewed, game usage) via Firebase analytics

2. How We Use This Information

We use your information solely to:

- Provide you with TestFlight access to the AAVE Bible App

We do not share your information with advertisers or external marketing firms.

3. Trusted Third-Party Services

To operate efficiently, we use trusted third-party services who process data strictly on our behalf:

- Zapier: to automate welcome emails and communication workflows
- Firebase by Google: for authentication, app usage analytics, and crash reporting
- Google Sheets: to manage and organize beta signup data internally

These services are governed by strict confidentiality and security practices and are only permitted to process your data according to our instructions.

4. Sharing Your Information

We do not sell, rent, or share your personal information with third parties for their own independent use.

All data handling is strictly for internal operational purposes during beta testing.

5. Data Retention

We will retain your information only for the duration of the beta testing period.

Upon full release or conclusion of beta testing, non-essential personal data will be deleted.
