5. No late applications will be accepted.

Due Date: 5pm April 22, 2022. All applicants need to reserve May 20, 2022 on their calendar to attend the awards ceremony (via Zoom). Winners will be notified by May 6, 2022. Winners will need to put together a Powerpoint and give a short presentation about their program.

6. NOMINATORS do not have to be NCACES members. NOMINEES MUST BE either current NCACES members or eligible for membership. For Team awards, the team leader and at least one team member must meet this criteria. Nominees must join as members after award notification if they are not current members. NCACES membership is open to Extension program and staff development professionals including Specialists, Faculty, Associates, Program Coordinators, and Area Specialized Agents. Dues, collected by the Treasurer at association meetings, are \$20 annually. Special consideration will be given to Agent or county stakeholder nominations for the Outstanding Specialist Award. Awards will be reviewed by the NCACES Awards Committee which is selected by the NCACES Board of Directors. Recipients from the previous year are not eligible for an award.

Preference will be given to nominations in which ALL team members have membership in NCACES and that have 1 or more County-level agents as a part of the team.

The Individual Award celebrates the expertise and primary efforts of an individual in a specific subject matter program. Preference is given to nominees that have demonstrated collaboration with other Specialists, Associates, Program Managers, and agent colleagues to support their work.

1. What are the critical issues and specific program objectives addressed by this nominee, or nominee team's educational program?
2. Who is the target audience of this educational program and how is the individual or team's program successfully being used, distributed, and marketed to the intended audience?
3. What are observed and documented results that make this an outstanding program?
4. What is the role of NCACES member or members in the program?
5. How does this program fit in with NC Cooperative Extension's Mission or Strategic Plan?
