Community members living within the school district's boundaries may purchase an access card for \$10 which is for lifetime use. Community members are defined as a person who has a physical address within the school district's boundaries. Only one card per family will be allowed.

Anyone who is not a community member may purchase an access card for \$75. A non-community member must pay the access fee on a yearly basis. Only one card per family will be allowed.

Access cards that are lost, stolen or damaged require a \$10 replacement fee.

Each user must swipe their designated access card. Anyone found using someone else's card will be asked to leave the facility and both parties' access will be terminated.

In consideration of being allowed to participate in the use of the Fitness Center and its equipment at the School District of White Lake, in addition to the payment of any fee or charge, I hereby waive and release the School District of White Lake and its officers, agents, employees, representatives and others at the School District of White Lake from any and all responsibilities, liabilities or claims from injuries or diseases which are the result of negligence arising out of or in connection with my participation in use of the Fitness Center and its equipment. This release does not preclude claims based on reckless or intentional conduct. I assume any and all risks due to my participation in this activity and acknowledge that my participation can place me at risk of bodily injury or death. I acknowledge that this is a voluntary activity on my own time. I understand the terms and conditions of this release and sign voluntarily.

Release of Liability _____ **(Member Initials)**

Members and above listed family members understand and agree that this is an unsupervised fitness center which may be accessed by members during the hours of 4:00 am until 10:00 pm every day of the week. Members and above listed family members acknowledge that at times there will be no employee on site to provide assistance in using the equipment. In recognition of the possible danger connected with any physical activity, member and above listed family members hereby knowingly and voluntarily waives any right or cause of action now or hereafter, of any kind whatsoever, arising from the use of the School District of White Lake fitness center or its equipment from which any liability may or could accrue to the School District of White Lake. Member will reimburse for any damages he/she, or a family member thereof, may cause to the equipment and/or the physical infrastructure of the facility. Member also understands misuse or abuse of equipment and facilities of the School District of White Lake or other misconduct as determined by the School District will cause suspension or termination of his/her entire family's membership. Members understand and agree that school use of the fitness center will receive preference. Times that the fitness center will be unavailable, due to school use, will normally be posted in advance.

Hours of Operation _____ (Member Initials)

If this is a family application, the undersigned agrees that each member of his/her family to be covered has agreed to also assume the risk of injury as stated above and the undersigned will indemnify and hold harmless the School District of White Lake, its employees and agents, from any such claims for injury and damages brought by such family member. Minor family members (children ages 6th grade - 15 years) must be accompanied by a person 21 years of age or older when using the School District of White Lake fitness center for non-school purposes. Children who have not yet started their 6th grade year will not be allowed to use the fitness center facilities.
