#### #1 - APPOINTMENT OF JOSEPH HOOPER AS CROSSING GUARD

- Mayor Hogan reviewed the City's recent purchase of smoke alarms, in wake of a tragedy on Front Street. The alarms are for individual homeowners only, especially those who do not have sufficient alarms. The alarms were purchased at minimal cost through the City's Community Development program, the Mayor said. Fire Chief Smith has drawn up a liability-release form for those acquiring the alarms. Chief Smith said a number of residents already have taken advantage of the program, including some who did not previously own smoke alarms.
- Vaughn Bates asked the City to make sure streets like Adams Avenue are sufficiently cleared on the mornings of weather events. Most people on those hillside streets work, he said, and the streets aren't cleared of snow and ice when they leave in the morning. Mayor Hogan said the issue was brought to him by Alderman Hann. The problem is especially worse with freezing rain, such as occurred earlier this week, the Mayor said. The Department of Public Works relies on the Department of Public Safety for early notification of icy spots, Mayor Hogan noted, and with the most recent event the DPW was called at 5 a.m. and told that the hilly streets were sufficient and to focus on downtown intersections. Normally, the DPW does the hilly streets first and it takes the City's one salt truck about 75 to 90 minutes to run a complete loop around the City. "Certainly, we'll endeavor to do a much better job on notification and timeliness," Mayor Hogan told Mr. Bates. "We'll continue to make that a priority."
- Alderman Hann asked Police Chief Murray to ensure that motor vehicles at the Taylor/Buffalo street intersection are given the right of way by crossing guards, instead of being made to wait on the tracks with the potential of oncoming trains. Chief Murray said he would investigate.
