Introduction (Cambria, 12pt, bold)

This section describes the problem that arises from a gap between the expectation and the actual condition (reality). There are several kinds of gaps: the theoretical (conceptual) gap obtained from literature review, the empirical gap obtained from the results of previous research, the practical (contextual) gap obtained from phenomena in the field, threats and challenges, as well as opportunities. Researchers must be able to distinguish between problems and symptoms (signs/indications of a problem). Symptoms are generally easier to identify, while the problem is the cause of the symptom that needs to be investigated.

The introduction should explain the purpose, the urgency, and the benefits of the research. In this section, the state of the art and novelty of the research should be emphasized. The introductory section also contains what has been researched, what is currently being done, what will be done and what is the research gap. The paper should at least contain the Introduction, Literature Review, Methods, Results and Discussion, Conclusions, and Bibliography. (Cambria, 12pt, 1.15 space).

Literature Review (Cambria, 12pt, bold)

The theoretical foundation is a reference/framework for solving problems. Researchers must present an in-depth study of theories related to research. The theories described in this section are well-established theories such as agency theory, organization theory, production theory, consumption theory, behavioral theory, and so on.

Any research requires a theoretical foundation that meets the principles of recency and relevance. The principle of recency relates to science and should be up-to-date and representative. The

principle of relevance means presenting a theoretical basis that is closely related to the problem of the research.

This section also contains a provisional answer (hypothesis) to a problem. Provisional answers are written under relevant scientific knowledge/theory, empirical research (latest, at most 5 years) and clear as a basis for argumentation in reviewing the problem. The existence of a provisional conjecture indicates that the purpose of solving the problem under study has not been answered or has not been resolved satisfactorily. 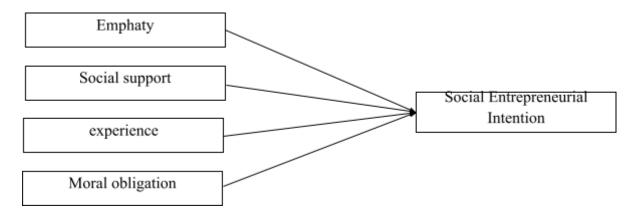


Figure 1. Theoretical Framework

Meanwhile, limitations and suggestions describe the limitations faced by researchers in conducting research and must be accompanied by an explanation of the positive benefits that may occur if researchers can do so. Thus, limitations do not only describe research constraints and suggestions for future researchers, but it also includes practical (policy) and theoretical implications. The practical implication is related to the contribution of research findings to strengthening practical/policy implementation (in real practice in the field). Theoretical implication is related to its contribution to the development of existing scientific theories. (Cambria, 12pt, 1.15 space).
