The Wethersfield Board of Education met in a workshop session on Tuesday, January 13, 2026 at 7:00 p.m. The meeting was streamed from Town Council Chambers, Town Hall, 505 Silas Deane Highway. 1. Pledge of Allegiance

Assistant Superintendent of WPS, Jennifer Frese-Miller led in reciting the Pledge of Allegiance.

2. Public Comment

Keane on Kids School Enrichment Program Director, Caroline Fazzina of 19 Fairmont St provided an update on the Keane for Kids After School Programs that are being held in each of the five (5) elementary schools and at SDMS. She noted availability remains in the programs and that financial assistance is available. She encouraged families to view the Wethersfield Parks and Recreation Winter Brochure for more information.

She noted the five elementary school programs include student performances as follows:

- Emerson-Williams School –Seussical (May 8-9)

Mrs. Fazzina also noted that Mrs. Andrea Aglieco continues her work in teaching the Hands-On Science school curriculum enrichment programs in the schools this year.

Mrs. Fazzina expressed appreciation for the support from all partners and mentioned Board of Education Member, Gabby DiBacco is also helping with the student performance after school program.

3. Communications

a. Human Resources & Personnel (01.13.26): Ms. DiBacco reported the committee reviewed the high-level responsibilities and upcoming schedule for collective bargaining negotiations, clarified the role of board members in the negotiation process, discussed the connection between negotiations and the annual budget and the upcoming negotiation timeline. Upcoming negotiations will occur with the following bargaining units: Secretarial/Paraeducator/Tutor union; Wethersfield School Nurses Association, and Wethersfield School Administration Association. Committee next steps were discussed. An orientation session will be planned for committee members to review the negotiation process, including parameters and ground rules, district financial projections, comparative contract data, relevant legal requirements and timelines.

b. Blue Path Update – Therapy Dog-Lenny

A presentation was made by members of the Webb School community and Principal, Ken Craig about the Blue Path organization and Webb School's therapy dog, Lenny.

The following individuals presented: Lenny's foster family, Kyrstin Giliberto and her daughter, Sophia; Lilia Grabowski and Kiernan McMahon presented their introduction of Lenny. The introduction included names of the dog handlers and noted the positive impacts Lenny has had on the school community. 4. Reports/Discussion Items

a. Standards & Benchmarks for District Operations-DRG D Comparison Charts (Ref.

1)

Superintendent Wihbey referred to the Board member packet, Reference Item #1 [Standards and Benchmarks for District Operations-DRG D Comparison Charts (January 6, 2026)] noting a vision for WPS's future pathways and outlining the minimum conditions required to sustain high-quality and service operations. Superintendent Wihbey commented on the twelve benchmarks for WPS district operation and noted the data presented was obtained from CT State Department of Education (CSDE) – *Report Cards* and *Dashboards*. This information will help with budget decisions in Wethersfield school district.

Board Comments: Ms. Callan Carson and Mr. Laccavole commented.

b. Advisory School Building Committee - Architect Recommendation for School Building Project (Ref. 2)

Advisory School Building Committee Chairperson, Emily Zambrello, provided an overview of the committee vetting process for the architect recommendation to the Board and Town Council for the WPS Elementary School Building Project. Town of Wethersfield Physical Services Director, Sally Katz was also present to answer questions from BOE members.

Board Comments: Mr. Laccavole, Mrs. Drew, Mr. Reilly, Ms. Callan Carson, Mrs. Gold, and Mrs. Granato commented. Town of Wethersfield Physical Services Director, Sally Katz also commented.

b.1. Recommended Motion: Approval of Advisory School Building Committee recommendation to Accept Vendor

Mrs. Granato MOVED that the Wethersfield Board of Education accept the recommendation of the Advisory School Building Committee to hire TSKP Studio as architect. The motion was SECONDED by Mrs. Gold and VOTED unanimously.

5. Board Comment

Mrs. Gold commented on the WECC meeting held yesterday and noted an ad hoc committee will be formed for purposes of looking at the future vision of early childhood care and education. More information is forthcoming about how to apply to be a member of that committee. WECC, as an official Local Governance Partner (LGP) with the State, had a Shine representative at yesterday's meeting. This representative supports WECC in ensuring compliance with OEC and State guidelines in WECC LGP role. As part of this work, WECC will be conducting a town-wide needs assessment and collaborating with Data Haven to analyze and utilize community data to make a clear coherent strategy for the future of early childhood education.

Ms. Callan Carson reported that the WSPC meeting held last week was very well attended. The Council is encouraging new guests and topics at meetings on an ongoing basis. A winter walk event is being planned for February and there is an Internet Safety Night with Scott Driscoll for parents at 7PM on February 2nd at Pitkin Community Center.

Mr. Reilly reported his attendance at the PTO meeting held at Highcrest School last Thursday. He noted there are many fundraising activities planned and that he has been responding to their questions about the schedule for the upcoming school building project.

Mrs. Drew congratulated the WHS Girls Indoor Track Team members for breaking a world record this past weekend at Yale University.

Mrs. Granato explained the new model for board meetings. Tonight's meeting was the new workshop model. Each month, the Board of Education has two (2) meetings. These meetings take place on the second and fourth Tuesdays of each month. The workshop meeting, now held on the second Tuesday each month, begins at 6PM with one or two committees in session at Town Hall. Residents are invited to attend said committee meetings, but there is no public comment. Following the 6PM committee meeting(s), the Board of Education then meets at 7PM

with an agenda focusing on the committee meeting(s) that was/were held. The next Board of Education meeting is Tuesday, January 27th at 7PM (with a regular agenda). Mrs. Granato thanked everyone for working on this change and provided the following quote: “The secret of change is to focus all of your energy not on fighting the old but on building the new.”-*Socrates*

WHS Student Representative, Anushka Gandhi provided the following update on recent events at WHS. The College Board recognized WHS AP Honor Roll due to the increased number of students enrolled in AP courses last year. Prior to winter break, WHS Seniors organized and participated in a Christmas holiday event where students enjoyed watching movie “Home Alone,” participating in arts and crafts projects, playing sports, and drinking hot cocoa. Each student was required to bring a canned good or contribute \$5.00 to participate. As a result, over \$400.00 cash was raised, and approximately \$1,000.00 worth of canned goods was contributed to the local food bank. Students are in full study mode with midterms exams on the horizon. Seniors have also remained busy, including ordering caps and gowns for graduation. Winter sports are underway. This past weekend, several football players were named to the CIAC All-State Team and WHS Boys Soccer player, Ramo Ahmetovic, was named GametimeCT Player of the Year for his outstanding season. WHS Girls Indoor Track set a new world record in the distance medley relay. Unified sports Basketball began last week and will run through February, and Ms. Gandhi noted she is assisting with that program.
