Test Info

If students are **scheduled for and sit for an AP exam, they are not required to attend their other classes that day.** This allows students time to prepare for a taxing exam and have time to take a proper break following the exam. Each class missed should be treated as an excused absence from the class, which means that students are expected to make up work and get content from missed classes. **Teachers are expected to record Zoom classes and make the recording of their classes available for students that miss class due to AP testing.** Students are still responsible for **submitting work by the 8 a.m. deadline on a class day** even if they will miss class for an AP exam. Students will have **five school days to complete missed assignments with no late penalty imposed.** Students who are taking multiple AP exams over the course of a week should reach out to their teachers to set reasonable deadlines for missed work.

See [this document](#) for information about **upcoming course final exams** (which are optional and virtual), as well as the **LEAP testing schedule.** Students who deferred their LEAP from the fall until the spring will be integrated into the testing schedule and should plan to be at school on the scheduled day of the LEAP test they deferred.

AP students: Ms. Can has manually moved each student who completed the Google Form into their requested AP Exam Administration window. **You are responsible for checking your myAP account to ensure that it accurately represents your requested AP Exam administration window.** Students who requested to take the AP exam digitally at home will soon receive communication about their room assignments.

AP testing begins on **May 3** and will take place in the Bicentennial building on UNO's campus. Please see [this map](#) to ensure you know where you are going, especially if you have never been there before. Room assignments will be posted at the entrance to the building on the day of your AP exam. Students are encouraged to arrive up to a half-hour before their scheduled AP exam as testing will start promptly. Students must bring pencils, calculators (if permitted), and a photo ID.
