on writing without being confused by the publication format. Changes from this template to the publication format are made by the JGE Editorial team.

The introduction describes the **background of the problem being solved, issues related to the problem being solved, and reviewing research that has been done previously by other researchers relevant to the research conducted. In this section, the author explicitly explains the state of the art, gap analysis, and research purpose.**

2. LITERATURE REVIEW

The content of the literature review section is written concisely, and only theory is used as the basis for research.

3. RESEARCH METHODS

Papers should contain writing that contains **1. Introduction, 2. Literature Review, 2. Research Methods (can include analysis, architecture, methods used to solve problems, implementation), 3. Results and Discussion, 4. Conclusion.** Each paragraph can consist of several *sub-paragraphs* written with Arabic numeral numbering, as shown in the following section.

The minimum number of pages is **10, and the maximum is 20 pages of A4 size.**

3.1. Review Stages

The review and revision process is carried out online through JGE's system. Please pay attention to the latest updates of your article and immediately revise the reviewed article.

3.1.1. Tables and Figures.

All **Tables** and **Figures** you insert in the document should be placed in the body text, after or before mentioning the **Table** and **Figure** to make it easier for the reader to notice the image's

meaning. **The table** and **figure** shown must be mentioned in the paragraph. How to write tables, fill tables, and caption tables and images you can see in the examples below.

In addition, it is important to ensure that the images have a suitable resolution for clear visibility. Images should have a minimum resolution of 300 dpi (dots per inch) and a minimum size of 1280x720 pixels. This will ensure that the images are of high quality and can be easily viewed and interpreted. When scanning or submitting images, please ensure they meet these resolution and size requirements. Graphs and diagrams should also be drawn with a line weight between 0.5 and 1 point for optimal clarity.

In-text citations for tables and figures should be done in a consistent and clear manner. It is recommended to use "**Figure 1**" when referring to a figure within a sentence, and use "**(Fig. 1)**" when mentioning it within parentheses. Similarly, for tables, use "**Table 1**" when referring to a table within a sentence, and use "**(Table 1)**" within parentheses.

3.1.3. Reference citations

Alternatively, you can use the author's last name(s) and publication year within parentheses. For instance, "Seismic inversion is a combination of seismic data... (Wibowo & Mulyatno, 2020)." Ensure that these in-text citations correspond to the full references listed in the Bibliography section. The Bibliography should be arranged in alphabetical order based on the authors' last names, following the American Psychological Association (APA) 7th style. Only include references in the Bibliography that have been cited in the manuscript.
