1. Open Meeting.

6. APPROVE and DECLARE VACANCY. Place 6 and Place 7 on the board of trustees. Motion was made by James Whitaker and seconded by Vrendia Combs to declare and approve place 6 and place 7 on the school board of trustees vacant. Motion carried 5-0.
7. APPOINT and APPROVE MEMBERS to James Whitaker for Place 6 and Dr. Carolyn Waldon for Place 7 for the vacancies on the school board of trustees. Motion was made by Vrendia Combs and seconded by James Whitaker to approve and appoint . Motion passed 5-0.
8. STATEMENT OF OFFICE and OATH OF OFFICE was administered by Lindsay White to James Whitaker and to Dr. Carolyn Waldon.
9. ACTION and ADOPTION to call a general school board member election for Place 2, 3, and 1 positions with expiring terms. Motion was made by James Whitaker and seconded by Vrendia Combs to take action and adopt a general school board member election for expiring terms. Motion passed 6-0. (Waldon voting)
10. ACTION and ADOPTION to call a special school board member election for Place 6 and 7 positions to fill unexpired terms. Motion was made by Vrendia Combs and seconded by

James Whitaker to take action and adopt a special school board member election for unexpired terms. Motion passed 6-0.

11. DISCUSS and APPROVE MOU Brazos Valley Texas Child Health Access (TCHAT). Mrs. Roberts reviewed the information and answered questions. Motion was made by James Whitaker and seconded by Suzi Elliott to approve the MOU for TCHAT. Motion carried 6-0.
