Warning Labels

In a significant move aimed at safeguarding the mental health of young Americans, U.S. Surgeon General Dr. Vivek Murthy has issued a formal advisory, advocating for the placement of warning labels on social media apps. This announcement, made on June 17th, is the latest effort by the Biden administration to address the growing concerns surrounding the mental well-being of adolescents and young adults, who are frequent users of these platforms.
