### What information do we collect?

When you use the App, we may collect and store the following information that does not identify you personally:

- A. The type, model, version, brand, language and resolution of device;
- B. the type and operator of network;
- C. The type, version name and version number of operating system;
- D. Device identifiers (for example:MAC Address, etc.,);
- E. Advertising identifiers (for example:GAID, IDGA, IDFV, etc.,);
- F. The time and duration of your use of the App;
- G. Behavioral usage of the App(for example:Page views, Click-through statistics, etc.,)

## How do we use your information?

We use the information collected through the App (individually or in combination) for the purposes described in this Policy or disclosed in the App. Specifically, we use the following to:

- A. License you to use the App and provide you with the App's features;
- B. Operate, develop, and improve the App;
- C. Provide you with personalized advertising;
- D. Respond to your questions and provide customer service;
- E. Identify, fix, and troubleshoot bugs and functional errors;
- F. Optimize or improve the App;
- G. Protect the integrity of the App and enforce our Terms of Use and other applicable terms, including detecting and preventing fraud and unauthorized activity, protecting our systems and services, preventing hacking and cheating, and generally ensuring the safety and fairness of the App, and detecting, investigating, and preventing potential violations of our Terms of Use or illegal activity.

## Who do we share your information with?

We or our service providers may disclose your information without your permission (i) pursuant to judicial or other government subpoenas, warrants, or orders or otherwise to comply with law; (ii) where we believe an individual's rights, property, or safety or security is at risk; (iii) if we find that your actions violate our Terms of Use; or (iv) where otherwise required or permitted by applicable law.

How do we keep your information secure?

We will implement reasonable security measures in accordance with applicable privacy regulations to ensure the security of your information. However, please note that no security measures are perfect or unbreakable. There may be security risks during the transmission of any information, and we cannot guarantee "absolute security."

How long do we store your information?

We will store your information for as long as necessary to fulfill the purposes for which we use it, unless we are obligated or entitled to store it for a longer period under applicable laws and regulations. Specifically:

- A. We will retain your information for as long as we have an ongoing relationship with you and until you cancel your account.
- B. We will retain your information for as long as required by law.
- C. We will also retain your information as necessary to maintain or improve our legal position (for example, in connection with the statute of limitations, security, litigation, or regulatory investigations).

What are your privacy rights?

You may have the following privacy rights:

- A. Right to withdraw consent. If we process your information based on your consent, you have the right to withdraw your consent at any time by contacting us using the contact information below. Withdrawing consent will not affect the lawfulness of processing before you withdraw it. If you withdraw your consent, we will no longer process your information for the purposes for which you consented.
- B. Right to rectification. You have the right to request that any incomplete or inaccurate information we hold about you be corrected.
- C. Right to erasure. You have the right to request the erasure of your information. You can request that we delete or remove your information if: (i) the information is no longer necessary, (ii) you have withdrawn your consent, (iii) you have objected to the processing, (iv) the information is unlawfully processed, or (v) the information must be erased based on legal requirements.
- D. However, we are not required to comply with your request if processing is necessary: (i) for compliance with a legal obligation requiring processing, or (ii) for the establishment, exercise, or defense of legal claims.
- E. Right to object. You have the right to object to our processing of your information where we are processing based on our legitimate interests. However, we will deny your request if we have compelling legitimate grounds that override your interests, rights, and freedoms, or if it is related to the establishment, exercise, or defense of legal claims. In this case, we will inform you of our compelling grounds and the balance of interests we have assessed.
- F. Right to restriction. If applicable, the right to restriction of processing means that we will continue to store your information upon your request, but will not process it further. In short, you have this right when we do not (or no longer) have any legal basis for processing or disclosing your information.
