

Guide to emailing Quiet Zone stakeholders

Important note: Emails are of public officials and have been gathered from organization websites and are available via a google search. This document simply puts them all in one place.

Please DO: Respectfully and candidly share how the suspension of the quiet zone has adversely affected you and/or your family friends, neighbors.

Please DON'T: Be insulting or rude in your comments. All of these people are pretty much like you and are trying to do the best they know how to at their jobs. They hold your sleep in their hands. Prevail upon their humanity.

Federal Railroad Administration. The FRA made the order to suspend the quiet zones in “the interest of public safety.” However this claim is not supported by the relevant [facts](#) nor did the FRA negotiate with the cities on mutually acceptable remediation dates. Encourage the FRA to:

- Conditionally reinstate a “partial quiet zone” from the hours of 10pm-7am for 60 days while cities complete upgrades to relevant rail-crossings
- Provide a reasonable notice period in writing (e.g. 60 days) prior to any future suspensions
- Factor the broader public health and safety impacts into decisions regarding suspension of quiet zones
