



By Mutual Agreement of the Governors

On Policy Regarding the Southern Border

Whereas, as the two states which border the nation of Mexico, the Southern Border presents a unique policy question for the states of Dixie and Fremont

Whereas, cooperation and unity in our objectives along the Southern Border could serve to benefit both the people of the states of Dixie and Fremont, and the nation as a whole.

Therefore, on this day, under the Watchful Eye of God, The Governor of the Great State of Dixie and the Governor of the Republic of Fremont have come to the following agreement.

Section 1. Declarations regarding the Southern Border

- A. The Two States shall, wherever possible, work to deter illegal immigration into our nation stemming from our Southern Border.
- B. The Two States shall, wherever possible, work to deter the criminal smuggling of harmful substances, including fentanyl, heroin, cocaine, and other various illegal narcotics. The definition of illegal narcotics

- here shall be based upon a mutually agreed compromise of the Two States' state laws in situations where legal differences arise.
- C. The Two States shall, wherever possible, commit to combating human trafficking and modern day slavery, the greatest of all evils practiced by the cartels.
- D. The Two States shall cooperate with federal law and law enforcement to ensure a quick deportation of illegal aliens found within our borders, and shall work with federal law and law enforcement to defeat and destroy the cartels that threaten our families.

Section 2. Declaration of Operation Southern Shield

- A. The Two States, authorized by their respective Governors, commit here and now to deploy at least five thousand soldiers of their respective state's National Guards to the Southern Border, in order to detect and deter illegal immigration, drug smuggling, and human trafficking.
- B. These operations shall be known as **Operation Southern Shield**.
- C. The manner in which this operation is carried out shall be overseen by the respective Governors of the Two States. In situations where the Governors are out of the state or otherwise unable to discharge the duty, oversight of this operation shall fall to the state's Lieutenant Governor.

Section 3. Declaration against City Governments that Aid Illegal Activity

A. The Governors, Michael D. Grant and Seldom237, do hereby condemn the policy of municipal jurisdictions that limit or otherwise hinder their cooperation with the national government's effort to enforce immigration law.

Section 4. Signatures of the Two Governors

- A. This document and the declarations it entails is hereby signed and endorsed by the Governor of Dixie, Seldom237
- B. This document and the policies it entails is hereby signed and endorsed by the Governor of Fremont, Michael D. Grant
- C. This document is not, and shall not, serve as legally binding law.

D. If either State chooses to relinquish the commitments made in this agreement, the other State shall not be automatically considered to have relinquished their own commitments made in this agreement.
