Key Terms Glossary

Advocacy: Public support for or recommendation of a particular cause or policy.

Board member at-large: A member of a board or committee who is not assigned to a specific role or portfolio and serves generally on the board.

Coalitions: Alliances for combined action, especially political ones.

Civic responsibility: The duties and obligations of citizens to society.

Diversified social and political capital: The expansion of an organization's network and influence across various social and political spheres, enabling access to more resources and support.

Log Cabin Republicans (LCR OC): A national organization representing LGBT conservatives and allies, with a local chapter in Orange County dedicated to promoting political pressure, advocacy, and rights.

Political pressure: The use of influence, lobbying, or public opinion to sway political decisions or actions.

Sponsorships: Financial support provided by an individual or organization for an event, activity, or person in return for advertising or other benefits.

Treasurer: An officer who handles the financial assets and liabilities of an organization.

VIP hour: A period of time before a public event or within an event, designated for "Very Important Persons," often offering exclusive access or amenities.

Vice-president: An officer next in rank to a president, acting as president in the president's absence.

Walk-ups: Individuals who attend an event without prior registration or ticket purchase.
