- Merge TGB and SC Calls
- Contribution from Stephen Curran:
- TGB Membership: A brief update on the need for a TGB Chair and any other updates from TGB members and prospective members about their availability and ongoing interest in participating. We'd like to get a better handle on TGB Membership.
  - Richard suggested a more detailed discussion around potential new TGB chair at the end of the meeting
- Technical updates:
- The CI/CD Update and Ubuntu Update
  - Steady but slow progress on the Ubuntu 20.04 upgrade
  - New artifacts build and in use by IDUnion
  - New tools for developers to make it easy to code and test locally
    - Still todo:
      - Automation to produce tagged Indy Node version
      - Completion of Sovrin artifacts started last summer
      - Automated to produce tagged Sovrin Node version
      - Upgrade all Steward nodes on Sovrin Networks
  - Mike Bailey - any timeline on upgrade of Sovrin networks
  - Stephen Curren - no timeline or due date as yet. Sovrin did a pile of work on Indy

Node Monitor the past month

- The did:indy DID Method work that has started (finally!)
  - Works started and BCGov “Code with Us” challenge won by Indicio and Dominic Worner.
  - Phase 1 - Work started on evaluation of the specification vs the code and adjust if needed.
  - Phase 2 - Implementation of specification in code
  - Goals:
    - DID identifier includes name of network holding the DID e.g. (did:indy:sovrin:mainnet:1234)
    - Full DIDDoc support
    - Resolving non-DID Anoncreds objects via DID dereferencing
- Standardizing AnonCreds efforts
  - Goal:
    - Make the de facto standard that is Anoncreds VC's as an open standard
  - Progress:
    - Idea is shared and received positively
    - Meeting held to kick-off the standardisation effort
    - Next meeting will determine where project will be incubated
      - Develop a table of contents of what specification should include
- Sovrin is EU Ready
  - Report on Digital Identity - ENISA issued a strong support for Sovrin
- Questions and answers
  - Richard - Participation is down due to various proposals / recommendations made but all been rejected
  - Stephen - Richard provide examples as you have been involved
  - Richard - Removal of token code for Ubuntu upgrade rejected among others, changes to Sovrin ledger fees
  - Stephen - Need to make decisions on what we think is best. Network use is going down
  - Richard - we had to reduce our Sovrin mainnet ledger writes due to Sovrin Fee policy changes
  - Stephen - we are all volunteers and not doing it for our own economic benefit. Main aim is to keep Sovrin mainnet available.
  - Richard - Frustrated with the lack of engagement from the Sovrin Board regarding recommendations made.
  - Line - we welcome recommendations and suggestions from anyone in the community. We are looking for a new chair for the TGB and the TGB is one of the most important in the community. Stephen cannot be chair and if we can't find a chair the Sovrin Board will need to appoint a chair. I am here because of my concerns regarding the lack of interest / support from the steward community. I am a steward myself. We need to respect that Daniel is too busy to continue as TGB chair. We need to find a new chair and move on.

- Steve - when we had a discussion about the fees before we agreed that the fees need to go up but the use of the network is the most important and to do things that stimulate the use of the network. If you can get users and usage you can monetise the results, whatever that means in terms of revenue. Users and usage is what we should be chasing. The elephant in the room is that Cheqd is stood up and don't see that the Sovrin token will be required or a reality soon. Would be good to get Evernym more involved again. Evernym also made some significant changes to libindy and upgraded to rust 2018.
- Steve - I will be happy to co-chair TGB with Richard but can't do it by myself
- Stephen - good discussion, how we build it up and keep it going is the most important. The headline of mainnet not operating anymore would be a disaster. There is a ton of things happening in the Aries community. We need to ensure there mainnet continue to be operational and available.
- Lohan - there is a lot happening on the Aries side of things but clearly a major lack of activity on the Indy
- Stephen - Continued focus on aries allows for flexibility and anoncreds is best when used with Indy. There is a ton of interest in Anoncreds and did:indy - those would lead to increased support and interest in Indy.
- Richard - much more optimistic regarding the last month than I have been the last year with contributions from IDUnion and new contributors.
- Richard - any update on the Sovrin financial situation
- Line - this year we have our AGM in March 30th and we are now working on the financial statements with the accountants. Discussion with the creditors is to make the debt long term loans, we still have large amounts of debt from 2019/2020 so we still have a challenge but the immediate danger to the Sovrin Foundation is not present. We have been working to eliminate the 5% interest on the loan and continue to work on this aspect.
- Richard - that is great news and congratulations.
- Stephen - disappointed that no other TGB members joined the call today. Will go back and speak to them regarding their positions and to ask if they are willing to help out further. We need a new chair and Stephen can't be the chair.

Steve missed the last TGB meeting due to a conflict in the calendar.

The biggest topic of discussion is still the updates regarding the CI/CD tasks required for the Ubuntu 20.04 upgrade.

The other topic of discussion was around the new pricing policy

- Workstream Updates
  - Health & Monitoring
    - No updates since the last meeting
  - Technical
    - Wade and team are making progress on the dependencies between Indy & Sovrin

- Resolved some authentication issues
  - Still working on the Github Actions and sorting out some authentication issues
  - No updates on token plugin. Token plugin code not completely upgraded due to funding issues and dev moving onto another project
- Community
- Steward Council Elections
  - Alex provide updates on SC elections
  - The plan was to follow the same nomination and voting process as before
  - However as we only had limited nominations we didn't require any voting and all nominations (from stewards in good standing) will join the SC members.
  - Xavi Villa is not a steward anymore and removed from SC membership
  - Mike Vesey (IDRamp) is not a steward anymore as they are not running a node and thus not a steward in good standing and removed from nomination and elections
- Steward Council Governance Changes
  - Alex and Lohan attended the SFGWG call last Monday to discuss potential changes to the SF governance structure to enable stewards to have some balancing power between the councils and the SF board decisions.
  - What is the voice of the steward council?
    - Not all stewards are equal - some just run a node, others are also a transaction endorser and other have multiple transaction endorser DIDs
    - Proposal to establish a majority voting mechanism for stewards
    - Steward council should follow the Robert's Rules of Order according to the bylaws of the SF governance framework
    - What are significant changes and when do other councils have the ability to cast a vote or provide their input/recommendations.
      - Significant changes are changes that:
        - Chair of the SC deems it significant and should be discussed with stewards first
        - The SF BoT deems it significant and asked to be discussed with stewards
        - A minority of stewards deems it to be significant
      - What is meant by **considered**?
        - SF is a Foundation, which means there is no democracy
        - We can first start by doing what we can within the current SF GF
        - And if needed propose SF changes into something else like a society or co-op. This will require legal changes and is a complicated process
        - The SGFWG is open to suggestions but they are not a legal department
      - Alex propose that we post the suggestions in Slack and discuss it

Question: what governance changes do we want to propose to ensure the steward council have a voice that MUST be considered by the board before significant changes are made?

Currently, there is a Sovrin Governance Framework, which says:

The Steward Council is responsible for representing the expertise, interests, and concerns of Sovrin Stewards in the Sovrin Foundation governance process. All members of this council are representatives of Stewards, and one of its chairpersons, if not already a Trustee, serves as an ex-officio member of the BoT.

The word "representing" seems to suggest some sort of mandate, while the council can only present; it does not vote. The current discussion about pricing shows there is confusion about this.

The governance issue can be split up in 3 topics:

1. What is the voice of the steward council?

Stewards present agreed that voting by mail would be the appropriate way to handle this.

2. What are significant changes?

Both Lohan, who attends all board meetings, and the Board could signal what changes can be considered significant, while also individual stewards can propose issues to considered significant.

3. What is meant by "considered"?

"Considered" can be formalized by adding rules, such as timeframes and an obligatory formal response, but can stewards take the same place as shareholders in a corporate structure, i.e. the highest ranking decision maker, and what would be the path to achieve that?

Lohan and Alex will take these points to the governance meeting and report back the results.

Maria from CPQD joined, Welcome! Line, who is a steward with Blokzone, but also a Trustee

- TGB Updates - Steve McCown

Daniel Hardman is the new chair. Discussion on the progress of the Indy Release. Things are coming together for Ubuntu 20 update. Next TGB we should have a proposed date for the release. The update to pricing has generated some discussion. The feedback was passed on to the Board. Don't want to relate too much just to keep this body independent.

- Indy Updates - Richard Esplin / Wade Barnes
  - CI / CD work continues. It is led by Robin and Wade. Wade is amazing and truly irreplaceable. Robin is the main contributor. We're not held up by anything thankfully but we need MORE CONTRIBUTORS. There is one more person from Estatus, he's working on his thesis and waiting for approval from his professors. Currently working on a proposal for the indy node update.
  - We had some contributions from Evernym previously
- Workstream Updates

Health&Monitoring - Wade did some amazing work.

Updates on indy-node-monitor: some good work and learnings came from this and is now culminating into the work @Wade is finalising to provide an easy to implement Indy network monitoring solution based on Docker containers. Indy-ledger-monitor and indy-graph might follow the same path in future. Connor added some additional graphs & charts. We are converting the monitor into a fully graphable and learning system.

Sovrin Steward compliance reviews: Work items have been broken down into tickets for the associated projects. List here <https://github.com/hyperledger/indy-node-monitor/issues> These would be great starters for new contributors.

- Current state:
  - Plenum CI for 16.04 and 20.04 is complete. The initial Plenum CD for 20.04 is nearing completion, requiring some publishing structure changes.
  - Differences between Jenkins and GitHub Actions has been documented here; [GitHub Action CI/CD Enhancements](#)
  - The CI/CD workflows from Plenum are being integrated into Node.
- Work to break the circular dependencies between Indy and Sovrin releases is resuming.

  - Work is on hold while work on the dependencies (Plenum, Node, and Indy Test Automation) are being completed.

You can nominate anyone (including yourself) who is a contact for a Sovrin steward in good standing, by responding to this email and listing his or hers name, email, and company.

The voting starts on Monday September 13th 12 PM UTC and closes 72 hours later on Thursday 15th at 12 PM UTC.

Each Steward organisation may cast one vote. The ballot link will be sent by email to the Steward Business contact. The ballot can only be used once.

The Steward Council will consist of no more than 15 members, nominated and elected by the body of Stewards.

The Steward Council will consist of no more than 3 chairs, nominated and elected by the body of Stewards.

- Sovrin Network Changes

3 resolutions were made: June 16, July 21, August 16

Stewards (all ledgers)

- The onboarding fee for a Steward is 750 USD.
- A Steward, no matter on which ledger, receives 1 MainNet Endorser DID for free (i.e. 100% discount on annual fee for 1 DID)
- All Stewards need to have a LEI (“GLEIF ID”) when applying, where possible (e.g., government exception)
- Handling existing (“clean up”): One year time to get a LEI
- Handling new: LEI mandatory when filing application

MainNet Endorser DIDs

- MainNet Endorser DID annual fee is 5,000 USD per MainNet Endorser DID
- MainNet Endorser DID fees are subject to annual renewal
- The Sovrin Foundation will consider a special 90% discount for a MainNet Endorser DID for an initial phase in individual cases, for e.g. volunteer-driven low-funded non-profits, educational organizations and global south start-ups

MainNet Tx Fees

- Ledger write fees remain as they are

StagingNet Endorser DIDs

- StagingNet Endorser DID 6 months fee is 500 USD, not renewable
- Removal of Endorser privileges for any StagingNet Endorser DID after 6 months
- Removal of Endorser privileges for StagingNet Endorser DIDs created prior to August 16, 2021 will commence on March 1, 2022

StagingNet Tx Fees

- Ledger write fees are the same as on MainNet but with a discount of 90 percent

BuilderNet Endorser DIDs

- Endorser DIDs remain free
- Removal of endorser privileges for any endorser DID after 6 months

BuilderNet Tx Fees

- Ledger transactions remain free of charge

## Questions and Comments received from community members

### Adoption Process

- I'm very concerned that the blog post claims the Steward Council and TGB were consulted, when in fact we were not. I now understand that the chairs of the councils were consulted. In the future, changes of this magnitude should come before the full bodies for us to provide feedback and be prepared to defend the change.
- Not being consulted in decisions like this undermines the value of participating on the Steward Council and TGB. Our Stewards are already poorly engaged. Changes like this could further reduce this vital participation and endanger the network.
- I now understand that the announcement triggers a 30 day notification and comment period, but the tone of the blog post is that this is a "done deal". There is no request for feedback or explanation of how to get in touch.
- The blog post is confusing. Alex pointed out a number of places where I misunderstood the proposal.
- I would like to see the economic model used to forecast the impact of these fees. I suspect a simpler schedule would drive almost the same amount of revenue without as much attrition.
- Raising fees without a public budget is not transparent and fosters suspicion about whether the money will be used appropriately.

### Onboarding Process

- Needing to get an identifier from a centralized third party in order to participate in our decentralized identity ecosystem is ironic at best, and could undermine the entire endeavor.
- When researching the Sovrin Token, we found a KYC provider who would KYC organizations for a reasonable fee with little effort. That fee can be rolled into the onboarding fee without much impact.

### Staging Net / Builder Net

- The stated goal of charging a fee to use Staging Net is that it will discourage production use. However, it does nothing of the sort. Once the DID is written, it is permanent, and the users can treat it as production.
- The right approach for discouraging production use on the test networks is already in the Sovrin agreements: reset Staging Net on a predictable schedule. Teams who are using Staging Net can automatically rewrite their DIDs, Schemas, and Cred Defs.
- Charging fees to experiment hurts adoption, especially when solution implementors cannot charge clients until they in turn move to production.
- It's confusing that the endorser removal period on Staging Net and Builder Net is different from Main Net
- A side-effect of having fees on Staging Net while not charging fees on Builder Net is that it should increase usage of that network, which will help with testing new releases. This

is a good thing.

- I don't see the point of removing Builder Net endorser DIDs on a regular basis. It won't change revenue or prevent long term issuer DIDs, but it will be annoying.

#### Main Net

- The recurring endorser fee is a significant increase in costs. I can get behind it because I appreciate that it spreads the financial burden in a helpful way, but the method in which it was announced undermines my confidence that I can trust this network as a stable basis for my production use cases.
- We currently have multiple endorser DIDs for different purposes (automated endorsement vs manual endorsement, different timezones, etc). The post looks like it is a fee per-DID, which is prohibitively expensive and so will encourage the sharing of endorser keys, which is bad practice.
- The blog post is not clear on whether Stewards receive an endorser DID for free. It's mentioned in Resolution 1, but not in Resolution 2 or in the Table. If Stewards are required to also pay to be Endorsers, what is the point in devoting resources to being a Steward? In resolution 1, it's not clear whether this applies per DID or per organization.
- Does Sovrin still expect to enforce the new fees on September 16?
- Where can we see Sovrin's proposed budget?
- What will be the process for writing DIDs to Staging Net after the fees are enforced? How long will it take? Will it slow down development?
- Is the fee per Endorser, or is it per Endorser DID? Are there recommendations for secure key management with a single Endorser DID?
- Do Stewards in fact get a free endorser DID? Is it limited to a single DID?
- Do existing Stewards need to get an LEI? Answer YES

#### Feedback from the council:

- Richard wants to see formal response
- The proposal in current version (in Richard's opinion) will not be effective because the staging net ledger is not being reset, so the DID will live there forever.
- Steve - we need to recognize that Sovrin needs fees to sustain the existence of the Foundation.
- We never tried to do "soft" push to mainnet.
- Richard - the paperwork and the delay are the hurdle, not the fee.
- Lohan - friction will come earlier, there won't be extra.
- Builder will still be anonymous.
- Stripping the privileges will be more

Next steps are for this CD work (<https://github.com/hyperledger/indy-plenum/pull/1541>) to be completed and then integrated with the 20.04 build processes in the <https://github.com/hyperledger/indy-plenum/tree/ubuntu-20.04-upgrade> branch. The same patterns can then be used and applied to the <https://github.com/hyperledger/indy-node> CI/CD process in the same branches.   - Sovrin running for 4 years makes it the longest running SSI ledger with demonstrated experience and stability.
  - Question about whether revocation registry counts as personal data on the ledger?  
Answer: it was not flagged as a concern during Sovrin's legal review of GDPR compliance in 2019.

- Discussion with Riley from Trinsic
  - Trinsic is a developer tool. Not much of a sales team, so not much interaction with their customers to understand use cases and adoption status.
  - The Trinsic business model:
  - Trinsic charges for credential interactions, which gives it a recurring revenue



stream, even if these credential interactions are based on one did only. This is clearly a more attractive model than Sovrin's, which would charge for just the one DID write, and is not able to charge for credential interactions.

- Customers are offered the choice between Sovrin and non-Sovrin networks like Indicio
- Trinsic customers usually start on staging but may move to mainnet voluntarily, once their numbers go up, and/or they feel the need for a more stable environment. Trinsic does not prompt them to move to mainnet though, mainly because it has never been asked to do so. Indicio offers a similar structure, with a free testing ground and a paid professional environment.
- Trinsic customers view Indicio as having more financial means, and thus a more professional organisation with more support. But it is commercial and with a centralised government structure, both of which feels contradictory to the concept of SSI. Sovrin on the other hand is perceived as having a truly open and decentralised governance.
- Conversation about Staging Net vs Main Net
  - Customers seem to believe Staging Net will be around forever.

Lohan: 1<sup>st</sup> all steward meeting since 11 July 1 meeting per month for all stewards in order to listen to the stewards needs. Introducing agenda, no comments on minutes. Highlights from the Steward Council Charter : the purpose is even more relevant now that we are moving into a network of networks.

Lohan suggests a non compliance steward workstream.

Council needs to approve upgrades to the mainnet.

Approving stewards is not task for council

Three workstreams:

- Workstream 1: monitoring and health, see slide. Indyscan is familiar to everyone
- Workstream 2: technical, has no lead
- Workstream 3: community

All workstream are volunteer-run and communicate as they see fit, open to all workstreams

Health: develop open source tools to monitor the ledger. Anonymous queries are possible, with a did you get more info. Three implementations: Prometheus + Grafana, Splunk, Public Dashboard - Indyscan

Workstream 3: main goal is to get stewards to work together, use things like interoperable wallets. Eat your own dogfood: developer exchange that Bcgov was developed to create capabilities that we can share.

Code release criteria: all Stewards are invited to contribute to defining the criteria for code releases to mainnet, this leads to decentralized governance of mainnet. See presentation for document dedicated to this subject.

Sam Smith:

1. stresses the need for steward participation in the decentralized governance process.
2. Foundation moved to sustainability mode. We have a plan, including the debt, we have an agreement to raise money, with everything raised below 300k will go towards sustainability, while above that threshold will be used to make payments on the debt.
3. We recognised that SS for all fits with a network of networks approach. In 2017 a single ledger could address all issues, now we know the situation with GDPR, anti money laundering regulations etc needs different networks that are interoperable. A steward survey will reveal what ledger properties they are interested in. One will be a network with a token, a convertible virtual currency with a floating exchange rate. Stewards might host nodes on different networks, and a token might offer an incentive.

One token proposal was to create a foreign (Swiss) token company and trade debt into equity in a foreign jurisdiction. Are stewards interested in joining that network?

This is all part of the network of networks approach.

The exact nature of the token determines the regulations Sovrin is subject to.

How do we get to a token:

The token taskforce investigates the feasibility and discuss the relationship between Sovrin and the tokenco. The survey will tell how the community feels about the token in general. Anyone interested should join the token taskforce, and read up on the way FinCen views the different kinds of tokens
