





# **Immigration Court Reform**

## Introduction:

Our immigration courts are in desperate need of reform. The current system suffers from a crushing case backlog, politicized hiring, and undue political influence, among other issues. The immigration courts are housed within the Department of Justice (DOJ), meaning immigration judges are under the control of the Attorney General (AG). The AG has used his authority to undermine our asylum system and strip immigration judges of key docket management tools, robbing them of their judicial independence and curtailing due process. The system simply cannot guarantee a fair day in court.

A perfect example of the systemic dysfunction is the tent courts at the border. Asylum seekers subject to Remain In Mexico, also known as the "Migrant Protection Protocols," are sent to tent courts in Laredo and Brownsville, Texas where their hearings are conducted via video teleconference. No judge is present in the actual rooms where the hearings take place and the small percentage of asylum seekers who have an attorney have limited time for consultation. These issues, along with the limited public access to these hearings, raise serious due process concerns.

For these reasons and more, AILA, the National Immigrant Justice Center (NIJC), Human Rights First, the National Association of Immigration Judges (NAIJ), the American Bar Association (ABA), the Federal Bar Association (FBA), and others have called for immigration court reform so that everyone has a fair day in court.

# Flaws in the Court System

Unlike other judicial bodies, the immigration courts lack meaningful independence from the Executive Branch. The Executive Office for Immigration Review (EOIR), which manages the immigration court system, is part of the DOJ. @DOJ\_EOIR #JudicialIndependence #ProtectDueProcess

Due process rights & #JudicialIndependence must be paramount in immigration court, where judges adjudicate asylum requests for those who fear life-threatening harm & discretionary relief requests that could subject American families to permanent separation. #ProtectDueProcess
