



Approved Providers (APs) are required to complete the following training to be eligible to support districts awarded the 2025-26 LASO Strong Foundations grants. Approved Providers must complete required certification training prior to delivering support to their contracted LEAs. Approved Providers will also be required to attend ongoing support (e.g., monthly meetings) to maintain certification.
